Bid documents can also be downloaded from www.etender.gov.za at **no cost**.

Completed and signed tender documents must be sealed in an envelope and marked with the relevant project number and project description and be deposited in the tender box at Makhuduthamaga Local Municipality Offices in Jane Furse before the closing date and time.

The municipality shall adjudicate and award tenders in accordance with the Preferential Procurement Policy Framework Act. 5/2000 and the revised procurement regulation with effect 16 January 2023 on 80/20 points system where 80 points is a price for lease of municipal space and 20 points for Municipal specific goals according to the said legislation. Bids will remain valid for 90 (ninety) days.

The lowest or highest tender will not necessarily be accepted and the municipality reserves the right not to consider any tender not fully completed. Tenderers are required to initial each page of the tender document and sign where necessary.

1.2.15 Bid offers will only be accepted if:

a. **80/20 preference points system for tenders for income-generating contracts with Rand value equal to or below R50 million**

b. **80/20 points system** will be applied as per section 10.1 of the SCM policy and preferential procurement policy framework Act 2000,16 January 2023

$$Ps = 80 \left(1 + \frac{Pt - Pmax}{Pmax} \right)$$

Where-

Ps = Points scored for price of tender under consideration;

Pt = Price of tender under consideration; and

Pmax = Price of highest acceptable tender.

(2) A maximum of 20 points may be awarded to a tenderer for the specific goal specified for the tender.

(3) The points scored for the specific goal must be added to the points scored for price and the total must be rounded off to the nearest two decimal places.

(4) Subject to section 2(1)(f) of the Act, the contract must be awarded to the tenderer scoring the highest points.

2.4. Criteria for breaking deadlock in scoring

(1) If two or more tenderers score an equal total number of points, the contract must be awarded to the tenderer that scored the highest points for specific goals.

(2) If two or more tenderers score equal total points in all respects, the award must be decided by the drawing of lots.

2.5.Exemption

The Minister may, on request, exempt an organ of state from any or all the provisions of this Act if-

- (a) It is in the interest of national security
- (b) The likely tenderers are international suppliers; or
- (c) It is in the public interest

2.6. AWARD OF CONTRACTS TO TENDERERS NOT SCORING HIGHEST POINTS

1. A contract may be awarded to a tenderer that did not score the highest points only in accordance with Section 2(1)(f) of the Act.

2. If the entity intends to apply objective criteria in terms of Section 2(1)(f) of the Act, the entity should stipulate in the tender documents.

10. Pricing Instructions.

The Service Provider is required to provide the services in accordance with the Scope of Work. This embraces all things necessary and incidental to complete the work.

11. SCOPE OF WORKS

11.1.1. The role of the appointed service provider is to provide canteen service(selling of goods and services) for sit-downs and takeaway meals for all municipal community including councillors and Staff.

11.1.2 The Service Provider may be invited to give a presentation of their proposal and / or service they provide, if or when deemed necessary.

11.1.3 The lease term shall run for twelve (12) months from the date of appointment

DESCRIPTION OF THE SERVICE REQUIRED

11.2.1. The appointed Service Provider shall be required to serve packaged take-away meals and sit-in meals.

11.2.2. The appointed Service Provider shall be required to offer a wide range of products that are compatible with the tastes of the municipal environment.

11. 2.3 The Service Provider shall be required to have well-functioning catering equipment, including but not limited to food warmer trolleys.

11.2.4. The service provider should have a well-equipped mobile kitchen with fridge, gas stove , frier and micro oven.

CATERING INDUSTRY REGULATORY COMPLIANCE

11.4.1 The Service Provider must ensure compliance with standard regulatory procedures and industry norms.

11. 4.2 The Service Provider must ensure that all catering related is adhered to e.g., Occupational Health and Safety Act, HSCCP Principles .

MAINTENANCE AND EQUIPMENT

11. 5.1 All the municipal equipment within the canteen environment will be maintained and if broken replaced on the condition that the damage was not due to negligence by the Tenant.

11. 5.2 All fixed equipment shall remain the property of the municipality upon the expiration of the lease and / or termination thereof, no fixed equipment or facility improvements will be tampered with or removed from the Canteen facility

11.5.3 The municipality reserves the right to inspect the premises at any given time.

OPERATING COST

11.6.1 The appointed Service Provider shall be expected to pay a deposit equivalent to the rental amount plus the actual rent for the first (1) month, thereafter, pay monthly rental fee for the duration of the lease.
