In terms of Clause **C.3.2: Issue Addenda** in the Tender Data, the City of Cape Town may if necessary, issue addenda in writing that may amend or amplify the tender documents to each tenderer during the period from the date the tender documents are available until one week before the tender closing time stated in the Tender Data. The Employer reserves its rights to issue addenda **less than one week before the tender closing time in exceptional circumstances.**

Your attention is specifically drawn to the amendments, which are to be made to the tender document for the above in terms of this addendum, which is issued in terms of Clause 3.2 of the tender document.

This notice to tenderers is an integral part of the Tender. This notice/addendum is to be signed by the tenderer and attached and/or included to the tender document submission and recorded on Schedule 22: Record of Addenda to tender documents.

This notice contains the following:

- 1) With reference to Item 5 of the Site Clarification Meeting minutes, all prospective tenderers who are interested to visit the site must notify Mr. Izak van der Merwe at izak.vandermerwe@zutari.com no later than 17:00 on Wednesday, 23 July 2025, should they not have done so already. Thereafter, site visit arrangements will be communicated directly to the tenderers who have submitted such notification.
- 2) Clarifications received since the issuing of Addendum number 6.

Requests for clarifications received since the issuing of Addendum number 6, and which don't require an addendum to the tender documentation, are addressed hereunder for the benefit of all tenderers.

Query 1:

Q: Please provide drawing 1001757-2000-PID-PP-2064 - reference is made to this drawing on drawing 1001757-PID-PP-2060

A: Refer to revision T1 of drawing 1001757-2000-PID-PP-2060 (attached) were the reference to drawing 1001757-2000-PID-PP-2064 has been removed. Refer to drawing 1001757-2000-DRG-FI-2796 and specification SPE-FI-0001 included under C3.7.5 in Volume 1A for information on the fire pump system.

Query 2:

- Q: With reference to specification C3.7.7.1 and drawings 1001757-2000-PID-PP-2051 to 2054 please confirm the Head at which the brine pumps (45-PMP-001 to 45-PMP-004) are to deliver (continuously) 96L/hr
- A: The brine pumps in question should be included as part of the Sodium Hypochlorite Generator vendor package. The required head for the brine pumps is dependent on the specific type of electrolyser proposed by the tenderer/supplier. As such, it is the responsibility of the tenderer/supplier to determine the appropriate pump head based on the characteristics and hydraulic requirements of the selected electrolyser. The pumps must be capable of generating sufficient head to ensure the conveyance of brine through the electrolyser—where it is converted to sodium hypochlorite—up to the sodium hypochlorite storage tanks.

Query 3:

Q: The CoCT standard details/door & windows schedule as referenced in items D2.134 - D2.152.

A: Refer to Notice 3 where the reference to CoCT standard details have been removed. All required standard details and schedules are included within the tender drawings.

- 2. Tenderers must sign and return this Notice (append to the relevant returnable schedule) together with their completed tender document.
