According to the National Tourism Sector Strategy (NTSS), tourism is fundamentally a collaborative endeavour for destination businesses in that tourists experience a destination in its entirety, and the success of their experience depends on all parts of the value chain working together seamlessly.

Tourist guides are an important part of this value chain as their role is to educate, interpret, and highlight the cultural and natural heritage for tourists, thus enhance visitors' experience. Tourist guiding is a much -specialised field that requires in-depth study and assessment of a particular area. The Tourism Act 3 of 2014 strongly discourages any person not qualified professionally, or legally to work as a tourist guide as that constitutes an offense. Accordingly, the Tourism Unit of Ingquza Hill Local Municipality intends to improve the capacity of aspirant tourist guides to operate legally, thus becoming compliant and adhere to the required tourism service standards.

**1. OBJECTIVES**

The objective of this mini-bid document is to appoint a suitable service provider to provide the NQF Level 4 Adventure Site Guide training.

**2. SCOPE AND DEFINITION OF WORK**

Accredited service providers are hereby requested to provide and deliver Skills Programme NQF Level 4 Adventure Site Guide training. The training delivery should consist of facilitation & practical assessment.

Training should cover areas that will qualify learners to:

- Conduct a guided adventure experience,
- Minimise and manage safety and emergency incidents.
- Manage and organise groups.
- Lead participants through an outdoor and education activity.
- Conduct a tourist guiding activity.
- Care for Customers

**3. EXPECTED DELIVERABLE**

- The **service providers** will be required to supply and deliver:

The appointed service provider will be expected to complete the work within 3 weeks from the date of appointment. The duration will consider the 7 days theory and 3 days practical.

**1. Requirements of the training provider**

1. The training provider must provide training manual for each learner and overhead projector.
2. The training must not exceed 5 working days.
3. The training Provider must Provide travelling and accommodation for the facilitator.

2.5 The target group for this program are 21 members of the community who are working at Tourism industry.

2.6 The training provider must submit CV with Qualifications, and proof of accreditation of the Facilitator 5 days before the commencement date of the training.

2.7 The training provider must sign service level agreement with the Municipality before implementation of the training.

**4. Accreditation**

1. Each training provider must be accredited by **CATHS SETA** (Adventure Site Guide Training). A valid Accreditation letter with accreditation statement must be attached to the Proposal.
2. The training provider must issue certificate within 4 months after completion of the training.
3. The training provider must inform the Municipality about CATHS SETA verification process and must submit verification report not later than 6 months after the completion of the training.
4. The training provider must submit the proof learner uploads on the National Learners Records Data Base (NLRDB) within 21 days after commencement of the training.

**5. BIDDERS SHALL TAKE NOTE OF THE FOLLOWING BID CONDITIONS:**

- A service level agreement shall be signed with the successful service provider.
- Ingquza Hill Local Municipality reserves the right to terminate the contract if not satisfied with the work produced by the service provider. Only bidders that have met the requirements of the proposal / specification shall be considered during the adjudication process.

3.3 Notwithstanding the above, the tenderer may submit a written request to the Ingquza Hill Local Municipality after the closing date for permission to withdraw the tender offer. Such withdrawal will be permitted or refused at the sole discretion of the Ingquza Hill Local Municipality after consideration of the reasons for the withdrawal, which shall be fully set out by the tenderer in the written request for withdrawal;

3.4 Should the tender offer be withdrawn in contravention of 3.1 to 3.3 above, the tenderer agrees that:
