The Training Service provider will be responsible for training of 18 learners that are to be recruited from the local communities within a radius of 10KM from Esibangweni in the Mthatha area where IDT implements projects under King Sabata Dalindyebo Local Municipality.

The IDT Skills and Training programme aims to empower the selected members of the communities where IDT implements projects targeting mainly women, youth and people with disabilities to obtain accredited qualifications to prepare them for formal employment or to start their businesses.

The targeted skills programme that the Training Service Provider must submit the RFQ for is the **Skills Programme: Handicraft Sewer.**

T2.1 SKILLS RATIONALE

The purpose of this skills programme is to prepare learners to operate as Handicraft Sewers. The Handicraft Sewer Skills Program has been identified to address the training needs of the unemployed and vulnerable groups, non-levy paying cooperatives, NGOs, religious and community structures through strategic partnerships and innovative project delivery. The Handicraft Sewer skills program will expand the skills base and contribute to the development of entrepreneurs in South Africa. Typical learners include both male and female learners where the age profile ranges from adolescent to aged. They typically have little or no sewing knowledge, experience and skill. These learners typically wish develop sewing skills so that they may earn an income in the informal sector, home—based cottage industry, incubation hubs and development initiatives sponsored by religious organizations.

Career Pathways

The Handicraft Sewer skills program will also contribute significantly to the building of small businesses and cooperatives, and rural development and most importantly, job creation. The final garments and household articles/products could also serve to boost exports as part of the Arts and Craft trade. During the skills program development process, the South African Apparel Association and the South African Quilters' Regional Guilds were consulted.
