

SECTION 2.1 SPECIFICATIONS**MINIMUM STANDARD TECHNICAL SPECIFICATIONS FOR SPORTS UTILITY VEHICLES (SUVs)**

The Hessequa Municipality requires the successful Bidder to supply the following:

TWO (2) NEW WHITE SPORTS UTILITY VEHICLES (SUVs)

The SUVs mentioned above shall comply with the requirements of the Standard Technical Specification, as detailed in the table below. It must be noted that Schedule A of the table lays down the detailed minimum requirements of this Specification while Schedule B must be completed by the Tenderer providing guarantees and technical particulars of the equipment and materials offered. Failure by the Tenderer to complete Schedule B could invalidate the tender.

CONDITIONS OF THE TENDER

1. Tenderer must have an authorized dealership and a fully equipped workshop within 150 KM from the Hessequa Municipal main building (**Civic Centre, Van den Berg Street, Riversdale**) for services and repairs. The service and repairs will only be done until the warranty expires.
2. The SUVs must be licensed and registered to Hessequa Municipality with number plate fitted before delivery.
3. All guarantees must be stipulated in the tender. Details of the guaranteed must be supplied. (**Attach proof**).
4. Proof of the said dealership or workshop must be submitted together with the tender. If the bidder does not have the said workshop or dealership, proof of a valid agreement with a local dealer or workshop owner must be attached. (**Attach proof**).
4. The licensed SUVs is to be delivered with full tanks of fuel to Hessequa Municipality.
5. The SUVs must be delivered within **FOUR (4) weeks or 20 Working Days** from date of appointment. The delivery period here stipulated shall form part of the contract and no delivery shall be accepted after the due date. Delivery shall be at the following address:
