#### 1. INTRODUCTION AND PURPOSE

Quotation for the supply, delivery and offloading of bush - encroachment and stump killers to the poison store (S010).

#### 2. BACKGROUND

The bush-encroachment herbicide will benefit the Electricity Department to sterilize the grounds around substations in rural areas so that they are not damaged by veld fires. The herbicide is also used to sterilise the ground under electric fences. The tree stump killers will benefit the Urban Forestry, Urban Management and Nature Conservation to kill invader weeds in the city.

The store issues the poisons via reservations on SAP under store S010.

The department is seeking to appoint one bidder for the all the items on the quotation.

#### 3. PROJECT SCOPE

##### 3.1 SUPPLY AND DELIVERY OF THE PRODUCTS

All products must be delivered to Poison Store- Store 010 situated at the Centurion Mega Store (252 Basden Avenue, Die Hoewes, Centurion).

Please note that deliveries can only be made by appointment with the Storekeeper.

- Delivery will only be allowed during office hours.
- Prices must include delivery charges.
- Labour for off-loading must be supplied by the bidder and the poison is to be off loaded inside the store.
- All containers must be intact as no damaged containers will be accepted.

- The weight or volume must be exact as to what is stated on the labels.
- Containers must be sealed as prescribed in Section 9(1) of the Law on Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act 1947 (Act 36 of 1947) - Regulations regarding fertilizers.
- All Labels must comply with the specifications. No product will be accepted if it does not comply with the specifications. The manufacturer's label must remain on the container. No poison may be decanted into smaller containers. The bidder must supply the Trade/product name product to be offered in table 2.
- All containers must be sealed and have at least 12 months shelf life before they expire.
- The labelling during transport as well as the transport of Poisons must be in accordance with:
  - SANS 10228: 2003: The identification and classification of dangerous goods for transport.
  - SANS 10229: 1996 Packaging of dangerous goods for road and rail transportation in South Africa.

### **3.3 PRODUCT LABELS AND MATERIAL SAFETY DATA SHEETS (MSDS)**

- The FIRST PAGE of the label outlining the product name and registration number of the National Department of Agriculture must be supplied in hard copy. They must be appropriately numbered with a permanent marker and the linked items stored together in a file.

- The trade name, the registration numbers and labels must be supplied as per the tables of products below and must match in trade name of the labels submitted.
- Only South African registered bush - encroachment and stump killers may be quoted.

## 4.3 Preferential points system

The preferential points to be used will be the 80/20 points system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2022.

- 80 points for price
- 20 points for specific goals
  - Bidders are required to submit supporting documents for their bids to claim the specific goal points.
  - Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated

specific goal points. Bidders will score points out of 80 for price only and zero (0) points out of 20 for specific goals.

- Cot shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

## 5. VALIDITY PERIOD

## 6. PRICING SCHEDULE

- The price must be quoted per 1 item requested. The quantities required will later be determined by the available budget.

## **7. MARKET ANALYSIS**

The city of Tshwane reserves the right to conduct market analysis. Should the city exercise this option, where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the tenderer if they will be able to deliver on the price, if a tenderer confirm that they cannot, the tenderer will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.

4. Each person whose signature appears on the accompanying bid has been authorized by the bidder to determine the terms of, and to sign, the bid, on behalf of the bidder;
5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
  - (a) has been requested to submit a bid in response to this bid invitation;
  - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
  - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium<sup>3</sup> will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
  - (a) prices;
  - (b) geographical area where product or service will be rendered (market allocation)
  - (c) methods, factors or formulas used to calculate prices;
  - (d) the intention or decision to submit or not to submit, a bid;
  - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
  - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

<sup>3</sup> Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
