### **Introduction to the NRF**

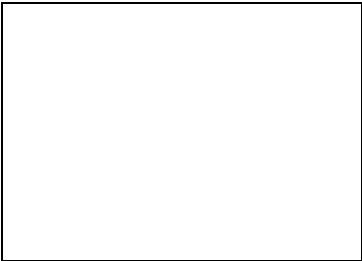
