1. BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

2. SPECIFICATION

The Iziko Museums of South Africa invites suitably qualified service providers to submit quotations for supply, installation, and commissioning of museum grade scent dispensing units, and specific scent cups.

The Imagined Conversations II exhibition is an immersive multi-sensory exhibition experience designed to engage museum visitors across multiple rooms. The installation creates a spatial auditory, smell and visual experience that surrounds visitors and allows them to experience the house coming back to life.

3. . SCOPE OF GOODS REQUIRED

The museum seeks to procure small, discreet, battery-operated scent dispensing devices (“Cups or jars and Scent Discretion Machines”) to enhance visitor experiences through carefully curated olfactory elements. The devices must be compatible with a wide range of scents provided by the supplier and should allow safe, consistent, and controlled scent delivery throughout exhibition spaces. Suppliers should have access to a comprehensive range of scents and demonstrate compatibility with the proposed devices.

Key Requirements Summary

- Devices must be small and discreet for placement near or behind exhibition objects.
- Battery-operated with sufficient life for typical daily operation.
- Capable of controlled release of scents without overpowering the exhibition space.
- Museum grade and compliant with Occupational Health and Safety needs.
