INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

BUSINESS UNIT RESPONSIBLE FOR THE BID

The business unit responsible for this bid is the conservation department at the Tsitsikamma Section of the Garden Route National Parks which is responsible for security operations within the park

CONTEXT OF THIS PROCUREMENT

The purpose of this bid is to invite prospective bidders to submit a bid for the provision of the security guard services at the Tsitsikamma section of the Garden Route National Park.

CONTRACT PERIOD

The Contract will be for a period of five (5) years

TERMS OF REFERENCE/SCOPE OF WORK

SITES TO BE GUARDED

The security guard services shall protect SANParks employees, information and assets against any damages, injuries, vandalism, theft, sabotage, death and any other security risk or threat.

- Daily execution of access and control at the specified areas as indicated by the Park Management

1. Patrol and safeguard buildings and areas as indicated below, seven days a week from

18h00 to 07h00 at Stormsrivier Mouth:

- Main entrance gate (guards will be stationed at this gate)
- Reception, Administration offices, technical stores complex, Admin Parking area, Otter room, Otter Parking area, Paul Sauer-Hoek residential houses.

2. Patrol and safeguard buildings at Tsitsikamma Big Tree seven days a week from 17h00 to 07h00

3. Patrol and safeguard buildings at Nature's Valley Rest camp seven days a week from 17h00 to 07h00

**4. The following sites will be patrolled and safeguarded when the need arises
– a vehicle will be required**

- Otter Camp area including service centre, oceanites (as and when required).
- Dolphin Camping area (as and when required)
- Restaurant area, Beach area, Guest houses and Petrusville (as and when required)
- Stormsrivier Village offices, when required
- Stores complex, when required
- Bloukrans complex, when required
- Tower houses, when required

DUTIES OF SECURITY GUARDS/SERVICE PROVIDER

- Gate control at the main entrance gates, record all visitors and vehicles entering and leaving the Park.
- Conduct random searches on all vehicles entering and leaving the Park, keep records of vehicles movement.
- Compile reports of incidents of security breaches taking place during shift operations.
- Carry out lawful security instructions/orders issued by identified SANParks representatives from time to time.
- React and report any emergency situations to the Senior Section Ranger/ Hospitality Services Manager/ Duty Manager or any SANParks official immediately when the emergency occurs.
- Assist with reporting of emergency to relevant emergency services, e.g. ambulance services, fire department, police station in the absence of SANParks official(s).
- Ensure that the security registers are completed, neat and up to date at all times.
- The Company must ensure quality service by adhering to SANParks operational plans and instructions. Operational plan and specific needs/duties/instructions will only be discussed with the successful bidder.
- Guards must be well trained in security services and must have traceable references, provide proof of security guards appointed.
- Ensure Guards appointed have no criminal records.
- Guards must be able to communicate in English and at least one other South African language (official)

- **Minimum Guards quantity and grade per site at all times.**
 - a. Stormsrivier Mouth Main gate: 2 x grade C guards.
 - b. Natures Valley Rest Camp: 2 x grade C guards.
 - c. Big Tree: 2 x grade C guards
 - d. Site or Shift Supervisor: with at least Grade C (Supervisor may form part of the 6 Grade C guards required above)
 - e. On Ad hoc basis, 2 grade C security guards will be required for a period of 30 days/ one month per year.

GCC5	5. Use of contract documents and information

The supplier shall not disclose, without the purchaser's prior written consent, the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure made to any such employed person is in confidence and shall extend only as far as may be necessary for purposes of such performance. 5.2. The supplier shall not make, without the purchaser's prior written consent, use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract. 5.3. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights, which the purchaser may have against the supplier under the contract.

Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

	18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
GCC1 9	19. Assignment

	20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract
GCC2 1	21. Delays in supplier's performance
	21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract. 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract. 21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority. 21.4. If the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. 23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated. 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years. 23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be
