



TENDER NOTICE AND INVITATION TO TENDER

South African National Parks invites tenders for the **RENOVATIONS OF CHALETS 1-15, THATCH ROOF REPAIRS TO ALL BUILDINGS & CONSTRUCTION OF 24 SHADED, PAVED CARPORTS AT MOSU LODGE, MOKALA NATIONAL PARK**

- a) It is estimated that tenderers must have a CIDB contractor grading **5 GB** or higher.
- b) Contractors registered as potentially emerging enterprises with the CIDB who are registered in one contractor grading designation lower than that required in terms of a) and who satisfy the criteria listed in the Tender Data (i.e. **4 GBPE**) and
- c) Joint ventures are eligible to submit tenders provided that:
 - i) every member of the joint venture is registered with the CIDB
 - ii) the lead partner has a contractor grading designation in the **5 GB** class of the construction work
 - The combined contractor grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered of **5 GB** class of construction work or a value determined in accordance with the Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations.
- d) Only tenderers who comply with the following are eligible to submit tenders:
 - Have the required and valid CIDB grading stated.
 - Achieved the minimum score for Functionality
 - Tenderer is not listed in the Register of Tender Defaulters and prohibited from doing business with the public sector.
 - The tenderer has not abused the Employer's supply chain management system
 - The tenderer has not failed to perform on any previous contract with the employer.

Take the N12 route to Cape Town from Kimberley, travel for 57km from Kimberley, until just past Wintershoek entrance, (pass the Lilydale Signboard), turn right at Hayfield / Heuningneskloof, crossing, onto a gravel road, travel 21km until you get to the gate of Mokala National Park on your right-hand side. The main Administration and Reception Building is a further 6km inside the park, allow about 70 minutes' drive from Kimberley to the main lodge.

Distance from Kimberley to Mokala Main Gate is 74km.

Tender documents will ONLY be available at the compulsory clarification meeting.
A non-refundable tender deposit **of R 300 payable in cash** is required on collection of the tender documents.

A **compulsory clarification meeting** with representatives of the Employer will take place at the **Park Management Offices Boardroom, Mosu Lodge, Mokala National Park** on **13 July 2023 starting at 11:00 hrs.** The Tenderer shall inspect and examine the Site and its surroundings and shall satisfy himself before submitting his tender as to the form and nature of the Site, the quantities and nature of the work and materials necessary for the completion of the Works and the means of access of the Site, the accommodation he may require and in general shall himself obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect his tender. The tenderer must be represented at the site inspection by a person who is suitably qualified and experienced to comprehend the implications of the work involved. Attendance of the site inspection is compulsory, and a tender will be disqualified if the site inspection is not attended by a representative of the tenderer.

The closing time for receipt of tenders is 07 August 2023 @ 11:00 hrs. Telephonic, e-mail and late tenders will not be accepted.

Tenders may only be submitted on the tender documentation that is issued.

Requirements for sealing, addressing, delivery, opening and assessment of tenders are stated in the Tender Data.
