It is Compulsory the tender submission achieve "Yes" allocation for all mandatory requirements listed on the table below in order to proceed to Stage2 If a "No" is allocated to one or more criteria then the submission will be considered non-responsive and will be disqualified

Returnable: Legible easy to read certified copies, documents issued by the external body ie Department of Manpower, Department of traffic, etc. Submissions should be certified and the date stamp must be less than 3months old from the date of submission. All legitimate copies on the date of submission should be Valid.
