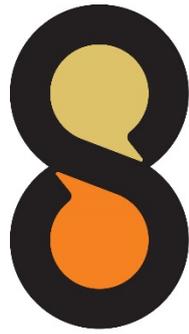

## 1 BACKGROUND

SALGA's data ecosystem has matured to include a maturing data lake with robust warehouses for various use cases, drawing from multiple data sources. These are meant for internal and external consumption. With the organisation aggressively pursuing the attainment of one of SALGA's Digital strategic product areas, a Data-Driven Local Government, SALGA seeks to launch a web-based portal that will serve as a data bank for municipalities and internal use, with a level of openness to the public for certain analytics and dashboards.

## 2 SCOPE OF WORK

The appointed services provider is expected to provide SALGA with the following:

### 2.1 Development of Dynamic Data Publishing Web-based Portal

- Enable a municipal and SALGA-wide centralised portal for dashboards and analytics, with features for self-service and ad-hoc data analysis.
- Enable the publishing of dashboards from multiple data warehouses and sources with interactive filtering, drill-down, and pivoting.
- Enable download data into common formats, including CSV, Excel, PowerPoint, and PDF formats, along with export capabilities of actual dashboards.

### 2.2 User Access and Security

- Ensure user and municipal verification to prevent unauthorised access.
- Facilitate user type management (for management of privileges)
- Data protection layer for any data classified as Personal and Sensitive

### 2.3 Integration and Interoperability

Enable access to and from various SALGA data analytic products and be embedded into other municipal and SALGA web and mobile applications.

Enable integration into 3<sup>rd</sup> party APIs such as location-based/map solutions, Power BI, and User Identity Management modules.

### 2.4 Navigation and User Experience

- Allow for easy navigation with minimal "clicks".
- Enable hierarchical navigation based on primary dashboards – as provided from data sources and pre-built visualisations.
- Provide for consistency and harmony in visual themes and "language"
- Enable a level of personalisation and adaptive user pathways/workflows
- Allow for filtering, speed of loading, and caching where applicable

### 2.5 AI Readiness

Ensure architecture supports the incorporation of AI Agents compliant with an AWS Stack and GCP stack to enable easier user navigation, data discovery, and self-service data analysis.

### 3 BIDDER REQUIREMENTS

#### 3.1 Specifications and requirements

- Develop and maintain a modern back-end web and mobile application in a data-heavy environment
  - including having built custom web-based applications in a multi-stakeholder and municipal platform
- Demonstrate the ability to develop web-based data-banks on both an AWS Stack (Amazon Quicksight, Quick Suite, Kiro, etc) and Microsoft stack (Power Platform) – with data and dashboards sourced from Power BI and additional visualisations customised in an AWS environment.
- Demonstrate the ability to deploy mobile-centric applications (APPS) and web applications on AWS back-end infrastructure and platforms.
- Understanding of SALGAs environment and multi-cloud technology stack, and ease of deploying an MVP within 2 weeks
- Future-Focused and AI-Ready Architecture to embed AWS AI Agents for easier navigation, data discovery, and data analysis.

In addition, the following principles – in line with SALGA Digital’s framework – will be expected:

  - Reference letter and/or links to solutions
- Proof of two or more partnerships with Microsoft, AWS, Huawei, GCP and/or IBM – as SALGA’s data ecosystem cuts across various cloud platforms

### 3.3 CV/Qualifications

- Capabilities and experience of the lead developer and Project lead - The bidder must provide a comprehensive CV/Profile of the lead developer and project lead, highlighting qualifications/certifications and relevant experience (i.e. as per specifications in 3.1)
- Experience in multiple public sector entities building web applications
- Experience in the development of public-facing applications (APPs)

1.1 The following preference point systems are applicable to invitations to tender:

- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

  - (a) disqualify the person from the tendering process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary.
