First stage evaluation is on the functionality criteria where bidders will be required to obtain a minimum score of 65 points each for A & B to qualify for the second stage being the 80/20 preference point scoring system.

Prospective Tenderers are requested to take note that the directives applicable in respect of the **Specific goals** as prescribed in the **Preferential Procurement Regulations, 2022** where 80 points will be scored for price and 20 points will be scored for specific goals as detailed in the tender document.


