

**FOR THE SUPPLY AND DELIVERY OF 671 X CZ75 PO7 - 9 X 19 MM-P HANDGUNS, 29 X GLOCK 19 GEN 5 - 9 X 19 MM-P HANDGUNS, 52 X 12 GAUGE MOSSBERG 590A1 – 9 – SHOT SHOTGUNS, 50 X LM5 - 5.56 X 45 RIFLES, PLUS RELATED ACCESSORIES TO GAUTENG.**

**1. Technical specifications**

- 1.1 Spare parts for repairs, after-market accessories, ammunition, retention holster upgrades, and maintenance must be readily available in South Africa (SA).
- 1.2 The firearm must be provided with related carry case, cleaning kit, and owner's manual.
- 1.3 The firearm must have at least 01 x spare magazine (same capacity) as supplied by the Original Equipment Manufacturer (OEM).
- 1.4 The firearms must be of robust quality finishing to avoid corrosion and with minimum operating parts to complicate the handling under duress.
- 1.5 Transnet prefers the types of firearms below. No alternative brands will be accepted. Any deviation from the specified brands will lead to automatic disqualification from the tender.
  - 1.5.1 CZ75 PO7, 9 x 19mm-P handgun;
  - 1.5.2 Glock 19 Gen 5, 9 x 19mm-P handgun;
  - 1.5.3 Semi-automatic LM5 5.56 x 45 rifle; and
  - 1.5.4 12 Gauge Mossberg 590-A1-9-shot shotgun.
- 1.6 The firearms must be supplied with the related accessories below.
  - 1.6.1 Carry case;
  - 1.6.2 Cleaning kit;
  - 1.6.3 Magazine pouch; and
  - 1.6.5 Spare magazine.

**2. General requirements**

- 2.2 Should it occur that any part or parts of the specification should be intelligible to the bidder or that the materials or the articles to be used in the execution of the works are insufficiently described, it is to be clearly understood that clarification shall be requested. The Bidder will be deemed to have carefully examined all the parts of this specification for this project.
- 2.3 Once the supply has commenced with the appropriate approvals for using any type and make of material or equipment, the same type and make of material or equipment shall be used throughout the project for that specific application unless otherwise specified.
- 2.4 The service provider will be responsible for storage of the firearms for a period of 12 months at own cost.

**3. Compliance**

- 3.1 The supplier must have a minimum of five (05) years of experience in the supply of firearms (Provide proof of experience).
- 3.2 The service provider must have a certified gunsmith for the specific tendered firearm as required by the Firearms Control Act (provide proof of License).
- 3.3 The service provider must submit a copy of their registration documentation as an official firearms dealer in South Africa.

- 3.4 The service provider must submit the official documentation/confirmation from the OEM / distributor to represent their product in South Africa.
- 3.5 Basic cleaning kit to be provided with each firearm.

  - 3.6.2 Quality of material and equipment has been satisfactorily demonstrated;
