One complete set of documents will be available from **Community Hall, Kgatelopele Local Municipality Offices, 222 Barker Street, Daniëlskuil, 8405** from **09:00 on Wednesday, 14 December 2022, from upon payment of an amount of R1 000 (One Thousand Rand and Zero Cents)**, which is non-refundable. Only cash payment at the Municipal Office or electronic funds transfer payable to Kgatelopele Local Municipality will be accepted. The Tender Documents will also be available at the compulsory site inspection meeting in Daniëlskuil.

A compulsory site inspection will be held at **10:00 on Wednesday, 14 December 2022**. The Engineer will be present at the briefing and all questions will then be answered. No further visits to the site will take place. Persons taking interest will gather at the **Community Hall, Kgatelopele Local Municipality Offices, 222 Barker Street, Daniëlskuil**. **Tenderers, who do not attend the compulsory site inspection, will expose their tenders to rejection.**

Only Tenderers who satisfy the eligibility criteria stated in the Tender Data are eligible to submit tenders. Tenders will be evaluated and adjudicated in line with the Supply Chain Management policy of the municipality using an 80/20 preference points system.

Bids will be evaluated on Functionality: The bid will be evaluated on functionality with the following criterion:

Quality criteria	Maximum number of points
Experience of Tenderer on construction of similar projects	40
Key personnel proposed for the project: Qualification and experience with projects of similar projects	20
Construction schedule and availability of resources/plant	25
Bank rating	15
Maximum possible score for quality (M_s)	100

NB: Bidders must score a minimum of 70% to be considered for further evaluation.

Tenders must be registered with the CIDB in a CE Class of Construction Works (**Grade 7 CE or higher**). Potentially emerging enterprises who satisfy criteria stated in the Tender Data may submit tender offers.

The contractor shall only appoint sub-contractors from the Daniëlskuil area and ensure that the incorporation of these sub-contractors with the contract will run smoothly.

NB: Bids may only be submitted on the bid documentation provided by the municipality.

Kgatelopele Local Municipality reserves the right to accept a part of a Tender and does not bind itself to accept the lowest and/or any Tender. Their Tenders must bind Tenderers for a period of **120 (One Hundred and Twenty) days** after the tender closing date. Tenders or copies of Tenders received by facsimile machine, electronic mail or per telegram will be considered. Tenderers attempting to influence the Client regarding the awarding of the Tender, after Tender closure, will automatically expose their Tenders to rejection.
