Subject to section 2(1)(f) of the PPPFA, the contract will be awarded to the tenderer scoring the highest points.



Installation

- The inverter and batteries must be installed by a qualified electrician with a valid registration with the
 Department of Labour. A valid electrical certificate of compliance (COC) must be issued once installed,
 specific to the installation of the backup system. The installation must be compliant with SANS 10142
 and ALL its parts
- The system and its components must have 2 years warranty. The system must be able to supply 230 VAC, at 18 Amps for 4 5 hours.
- After installation, the supplier must connect and configure the backup system for remote and online monitoring.



The installer must ensure that the system is designed and installed to be maintenance-friendly.

All isolators and circuit breakers must be properly installed and clearly identified.

A single-line block diagram must be submitted, accompanied by the necessary load and duration calculations, aligned with the requirement for 4–5 hours of backup time for the proposed system.

The installer is responsible for providing all components required for the complete installation.

Based on market research, preference is given to the Victron inverter and the Freedom Won eTower battery as specified.

The inverter must be of the pure sine wave type, suitable for driving motors
