1. SPECIFICATIONS

1.1. SCOPE OF WORK

- The service provider will be required to provide JW (Northern Works wastewater treatment in Diepsloot) with three cleaners to perform cleaning tasks for the period of 10 Months.
- The cleaners will be expected to perform cleaning services that will include but to be limited to the following activities.
 - Providing a comprehensive cleaning service to ensure a neat, clean, and healthy working environment always.
 - Maintaining and cleaning all areas as required and instructed internally and externally.
- Within the Northern Works Wastewater Treatment (In Diepsloot) the cleaners will be expected to perform tasks which will include but not limit the following:
 - Ensure that all floors are washed clean and dry.
 - Ensure that the toilets and urinals are kept clean and disinfected.
 - Ensure that water wastage is prevented.
 - Ensure that wash basins are provided with detergent and that toilets are provided with toilet paper as required (detergents and toilet papers will be issued by JW to the service provider In Northern Works)
 - Ensure that all walls and windows are always kept clean.
- Cleaning services will be conducted on fulltime basis which will be on Monday to Friday

1.2. GENERAL

- The contractor shall provide all necessary machinery, tools, and all relevant cleaning materials for the proper execution of the work. Such machinery / equipment and materials shall be suitable for its purpose.
- Such machinery / equipment to be provided by the contractor must be in good and safe working order. Sub-standard provision of services due to defective equipment will not be allowed by JW and all work on site must be in accordance with the Occupational Health and Safety Act (85 of 1993) and its regulations with all applicable signs to be provided where required.
- A full staff compliment must be based in Northern Works wastewater Treatment and contractors staff related issues must not impact on service delivery and must be resolved by contractor and not escalated to JW as this is a relationship between the contractor and their staff. Johannesburg Water will manage the contract at the appropriate level.
- Companies are required to utilize approved cleaning chemicals that are affiliated to a recognized trade association.
- Companies are required to provide Materials Safety Data Sheets (MSDS) for the cleaning chemicals used. Copies must be submitted to the site Managers.
- All electrically operated equipment shall comply with the relevant South African Bureau of Standards (SABS).

- The contractor shall undertake to provide and use environmentally friendly cleaning products / agents / materials as required by Johannesburg Water.
- The contractor shall be responsible for the efficient performance of the contract and for the good conduct of their employees whenever they carry out cleaning services in the various JW premises.
- All employees who are engaged to carry out works under this contract shall always, wear clean and tidy uniforms and put proper safety signage which shall be provided by the contractor. The staff is to work quietly and refrain from disturbing JW employees while performing work duties.
- The Works Manager (WM) reserves the right to give working instructions directly to the contractor's employees if in the opinion of the RM / WM /SM it is deemed necessary.
- All employees should be observant, keen, alert, efficient, willing, and pleasant. The contractor shall provide adequate staff to JW for the duration of the contract for deep cleaning and hygiene services. All employees shall have proper qualifications / competency required to use and operate the necessary equipment and chemicals when performing these tasks.
- Purchase Order will be a blanket order for 3 months, payment will be made monthly for the work done, if the contractor employees are not able to come to work for any reason, the contractor should provide a reliever to stand in.
- Service provider should provide proof of valid certificate of registration with NCCA (National Contract Cleaners Association)

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;

Bid rigging is, therefore, an agreement between competitors not to compete.
