1	I need to know who is supplying the cable and material, e.g., joints and terminations for the training because that will influence the pricing.	Eskom will supply the cable. Tenderers are to supply the accessories as stated in the TECHNICAL EVALUATION CRITERIA (Dated 17 November 2023)
		ADDENDUM FOR CENTRAL EAST CLUSTER MV AND LV CABLE ACCESSORIES point p) Clause 3.2.g of Eskom 240-56030619 Rev 3 states: "The supplier shall include a jointer training proposal or offer as part of any tender submission." This clause shall be interpreted as follows:
		Each successful tenderer shall be required to perform a full practical demonstration of the application of the following MV cable accessories:
		1. A Transition joint.
		2. A type 4 termination; and
		3. A Trifurcating joint.
		These sessions shall be used to ensure that all MV jointers used in the cluster are familiarized with the installation instructions and any product



		specific detail required to install the accessories correctly. Each session shall accommodate thirty (30) jointers who will actively participate in the demonstration under the supervision of the original equipment manufacturer (OEM).
		The tenderer shall supply the accessories as part of the demonstration. The smallest range taking accessory shall be used for the demonstration;
