The service provider should administer a battery of assessments that assess the applicant's personality characteristics, cognitive abilities and managerial level competencies in the key elements outlined below, for Chief Technology Officer, Executive Manager: Compliance Management, Project Manager: Science Engineering & Technology, Manager: Assets and Liabilities Management and any other position at management level that becomes vacant during this financial year position operating at Executive and Senior Management Level:

- a) Strategic Thinking, Conceptual & Analytical Thinking, Forward thinking.
- b) Ability to gain Organisational Commitment (Strategic Influencing, Relationship Building, Interpersonal Awareness, Concern for Impact, Developing others).
- c) Ability to Achieve Business outcomes (Result focus, Customer Focus, Concern for Excellence, Initiative, Critical Information Seeking).
- d) Self-Management (Independence, Tenacity, Flexibility, Self-development)

The service provider shall provide NRWDI with evaluation reports on each of the three candidates for each position, which report must provide a summary of the outcome of the assessments and make recommendations on the candidate's match to the above-mentioned key elements, and on areas of possible future development.

3. EVALUATION CRITERIA

3.1 Mandatory Requirement (At RFQ Closing Date)

- i. Service providers who fail to quote fully or according to the specification and scope of work will be disqualified.
- ii. Quotations that are not sent through the procurement central email will not be considered for evaluation.
- iii. Quotations submitted after the RFQ closing date and time will be disqualified.
- iv. Submit a minimum of three (3) reference letters for similar work done where top management positions were assessed.

3.2 Mandatory Requirements (at Award Stage)

- i. Non tax compliant Bidders will not be awarded the RFQ.
- Bidders listed in the Register of Restricted Suppliers or in the Tender Defaulters Register from National Treasury will be disqualified.

1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender:
 - the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
 - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).
- 1.2 The applicable preference point system for this tender is the 80/20 preference point system.
- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:
 - (a) Price; and
 - (b) Specific Goals.
- 1.4 The maximum points for this tender are allocated as follows:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (a) "black people" is a generic term which means Africans, Coloureds and Indians
 - a) who are citizens of the Republic of South Africa by birth or descent; or
 - b) who became citizens of the Republic of South Africa by naturalisation—
 - i) before 27 April 1994; or

- (b) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (c) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (d) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (e) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (f) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000); and
- (g) "women" means a person of female gender who is a citizen of the Republic of South Africa.

3.1. **POINTS AWARDED FOR PRICE**

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
