1. BACKGROUND

BANKSETA is a statutory body established through the Skills Development Act of 1998 to enable its stakeholders to advance the national and global position of the banking and micro-finance industry. As guided by its mandate the BANKSETA is an agent of transformation and will promote employment equity and Broad Based Black Economic Empowerment through skills development.

BANKSETA is a schedule 3A public entity with about 64 staff complement. BANKSETA head office is in Gauteng (349 Witch-Hazel Avenue, in Eco Park, Centurion) and has two regional offices at Polokwane and East London.

2. BACKGROUND TO ASSIGNMENT

The purpose for this service is that the BANKSETA seeks to appoint a professional service provider for the provision of the employee wellness expertise, to ensure that there is a continuation and non-interruption service. The required services will be in line with the SETA license period for a period of 3 years.

BANKSETA had contracted the services of the employee wellness service provider since 2012. It will be vital for the continuation of the employee wellness programme in accordance with the BANKSETA HR strategy. During the introduction of the employee wellness programme staff member's productivity increased including improvement in absenteeism.

The bidder responding to this Request for Quotation (RFQ) process must be the main respondent and should not be an intermediary/broker/3rd party or any type of middleman. Any of the arrangements mentioned above will be prohibited and not accepted.

3. SCOPE OF WORK

The scope of work will consist of the following for a period of three (3) financial years:

- Counselling services and trauma debriefing to employee's and families in common households.
- HIV/AIDS Management Program in partnership with the employee's medical aid scheme which includes prevention interventions treatment care and support;
- Health management services which includes chronic disease management, incapacity, health promotion, awareness and education; and
- Wellness management includes but is not limited to work life balance interventions such as stress management, retirement planning, and financial fitness.
- Provisioning of annual health screening assessment services for the duration of the contract which include but not limited to the following:
 - Voluntary counselling and Testing (VCT)
 - Personal health assessments and stress assessment
 - Hypertension (BP monitoring)
 - Blood sugar level testing
 - Cancer assessment/motivational talks
- Knowledgeable speakers available to present specific topics at (at least) two (2) events per year during the contract period.
- Reporting (Monthly statistical analysis, interpretation and recommendation for action, quarterly and annual report on all programmes.

4. EXPECTED OUTCOMES AND DELIVERABLES

- The employee wellness programme should increase productivity by providing a sustainable and confidential employee wellness service to all employees.
- To establish and maintain a holistic approach to support employees in managing their personal and social problems.
- To provide employees and their immediate family members with a comprehensive resource to help them address personal problems.
- To provide management with a practical resource to aid in the supporting employees with personal and work-related problems when they impact on an employee's performance
- To develop and improve the life skills and promote self-empowerment.
- To promote and encourage employee healthy lifestyles and maintain a healthy workforce

5. COMPETENCY AND EXPERTISE REQUIRED

The following minimum criteria apply to any organisation responding to this invitation to quote and supporting documentation should be provided: Failing to submit the below will lead to disqualification. THE BELOW ARE MANDATORY DOCUMENTS

- 5.1 Submit a minimum of three written references letter on clients letterheads where same assignments/ services were offered.
- 5.2 The prospective bidder must demonstrate the relevant experience in providing employee wellness programmes. Submit company profile clearly stating the years of experience conducting employee wellness programmes.
- 5.3 The bidder must confirm in writing that they are not intermediaries/brokers/3rd parties or any type of middleman.

6. DELIVERY OF ITEMS

This is for a period of three (3) years.

7. PRICE AND BBBEE

The preferential procurement point system applicable for this process is 80/20, as approved by the BANKSETA Board.

The RFQ will be evaluated based on the 80/20 principle being:

80 Points for price and 20 points for BBBEE

The BBBEE Certificate or a Sworn Affidavit for the exempted bidders to be attached.

8. COMPLIANCE STATUS

- a. The BANKSETA before making an award, shall check on the Central Supplier Database CSD whether;
- a) the bidder's tax status is compliant and
- b) the bidder or any of its directors are not listed / indicated as restricted from doing business with the public sector, and/or are person(s) prohibited/ its directors are not employees of the state and have no conflict of interest in the BANKSETA, or have written authority to do work with the state as per the legislation.
- b. The BANKSETA will not award to service providers who do not comply with the above.

9. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTOR

In terms of Regulation 6 (2) and 7 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

The points scored by a bidder in respect of the B-BBEE contribution will be added to the points scored for price in order to arrive at the overall score.

Points will be rounded off to the nearest 2 decimals.

In the event that two or more RFQs have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for the specified goals or B-BBEE contribution.

10. RFQ CONDITIONS

- a. BANKSETA reserves the right to withdraw or amend terms of reference by notice in writing by advertising in the media in which the RFQ was originally advertised prior to the closing date.
- b. BANKSETA reserves the right not to award this RFQ and the right to reduce the quantities awarded.
- BANKSETA reserves the right to verify the information submitted and request for further information during evaluation of the proposal.
- d. BANKSETA shall not be liable for any direct, indirect, consequential or other losses or damages including loss of profit that may be incurred by any person including, but not limited to, an Applicant, Short Listed Applicant or Successful Applicant, or any director, officer or associated company thereof, as a result of any reliance on or use of information supplied in response to this RFQ or as a result of the RFQ process contemplated in this RFQ document.
