1. High level background

Eskom Holding uses the Think Cell Microsoft PowerPoint and Microsoft Excel Add-on software. The Add-on is used across multiple divisions and departments within Eskom. Eskom currently uses 200 Think Cell subscription licenses. For this open tender, Eskom is requesting an additional 100 licenses from the market. This takes the total of licenses being requested to 300.

Think Cell software is an Add-On for Microsoft PowerPoint and Microsoft Excel. Add-Ons supplement the capability of a software tool; by adding non-standard functions. Add-Ons are software extensions or enhancements that add new features or functionality to an existing software program or application. It is designed to enhance the standard software's capabilities and provide additional tools or options for the user.

In the case of Think Cell, this means that Eskom users can execute functions in PowerPoint and Excel that are not available on a standard PowerPoint and Excel software package. Think Cell thus allows Eskom users the ability to execute complex functions, that otherwise would not be available to them.


In Eskom, this is mainly useful in creating reports and presentations. Eskom is used to reporting in a predefined manner. Think Cell is useful in illustrating complex analysis, that is otherwise difficult to communicate. It aids in improving employee efficiency in creating reports and presentations. It provides the ability to review and modify graphs instantaneously between different users.

The reports and presentations are created for stakeholders such as the following: Eskom Board, NERSA, Parliamentary communication, various senior committees and stakeholders from New Build, Board, Executive Committee (EXCO), and Department of Public Enterprises (DPE) to Department of Mineral Resources (DMR), National Energy Regulator of South Africa (NERSA), and Multi-Year Price Determination (MYPD) among others.
