ANNEXURE A

1. SCOPE

AAD is a key biennial international exhibition and is rated the top six in the world. It boasts more than 450 participating companies in the defence and aerospace industries from 30 countries. AAD Expo provides a conducive environment for business-to-business linkages, as well as an ideal platform for engaging in dialogue and discourse on international defence, aerospace and other related best practice. AAD 2026 will be held at the Waterkloof Airforce Base from the 16 – 20 September 2026.

Enterprise and Supplier development (ESD) is defined as monetary and/or non-monetary contributions carried out in favour of the beneficiary with the objective of contributing to the development, sustainability, financial and operational independence of those beneficiaries. The beneficiaries of ESD are Exempted Micro Enterprises (EMEs) and Qualifying Small Enterprises (QSEs) which are at least 51% black owned or at least 51% black women owned. Entities that qualify as EMEs and QSEs are entities with a turnover of less than R50 million in a particular financial year.

Armscor aims to identify companies across the country with manufacturing capabilities and capacity within the Defence Industry. The aim of this initiative is to support black SMMEs and contribute towards the growth of South African Defence Industry (SADI), Aeronautics, Technology to name a few.

2. BID EVAUATION PROCESS

Each received bid will be evaluated in 1-stage. A bid that does not comply with the requirements of stage 1 will be eliminated from the evaluation process.

3. ALLOCATION OF PREFERENCE POINTS FOR SPECIFIC GOALS

The preference points that will be awarded in terms of the specific goals with regards to procurement processes shall be as follow

Evidence required:

- The Bidder shall submit with the Bid documents the BBBEE certificate (BBBEE certificate issued by a SANAS accredited verification agency), or CIPC BBBEE certificate and or completed BBBEE Sworn affidavit as a proof of compliance to claim preference points.
- 2. If the Bidder is an unincorporated Joint Venture (JV) or Consortium, the Bidder shall submit with the Bid, a consolidated proof of BBBEE status.
- 3. Should the bidder fail to submit the evidence above, then the bidder shall score no points for PPS.
