A set of proposal documents can be obtained at a non-refundable cost of **R361.00 including VAT** for hard copies directly printed by the Municipality and **free of charge when provided on pdf via e-mail.** Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation for proposal and / or re-advertise or to reject any formal proposal or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this proposal may not materialize.

**The above requests** will be evaluated and adjudicated in terms of the **80/20** or **90/10** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2022) whereby the lowest acceptable tender will determine the preference point system to be used, and Oudtshoorn Municipality’s Supply Chain Management Policy.
