3. INTERVENTION OUTLINE FOR INDUSTRIAL PSYCHOLOGIST

Industrial Psychology focuses on the optimal development and utilisation of human resources in the work environment.

Industrial psychologist will be expected to combine elements of psychology and management to give professionals the skills to build effective, healthy, and productive employees.

The Scope of Work does not limit the Service Provider to the items mentioned below only. The Service Provider must cover / unpack all important areas to suit the targeted officials and aligning it with their levels.

Problem Solving
Negotiation and Persuasion
Data Analysis
Writing and Reading and Comprehension
Business Acumen
Social Skills
Teaching and Learning

4. PROBLEM DIAGNOSTIC AND INTERVENTION PLANNING

The Industrial Psychologist should be able to diagnose the organisational problems and plan appropriate interventions by:

- conducting needs and risk analysis, assess client requirements and priorities,
- defining the goals and outcomes of chosen psychological interventions through applying contextual knowledge, techniques, analytical skills and insight,
- defining and setting goals for the interventions, communicating these effectively to the client/s and identifying criteria for effectiveness and goal achievement.

5. INTERVENTION DESIGN

5.1 The Industrial Psychologist should be able to design appropriate interventions through:

- Applying appropriate knowledge and insights of the South African population and psychological measurement theories and techniques,
- Designing and/or developing client centered solutions,
- Designing or adapting tests, instruments, systems, and methods for the clients benefit.

6. PSYCHOLOGICAL ASSESSMENT

6.1 The Industrial Psychologist should have the ability to use psychological assessments to:

- Diagnose and assess human behaviour in a workplace-related setting by applying knowledge, theories and techniques of both psychology and psychometrics,
- Diagnose workplace related psychopathology (for example trauma, stress, and burnout),
- Assess individual and group perceptions, attitudes and behaviours.
- Assess organisation-level perceptions, attitudes and behaviours related to structure, culture and management styles and practices,
- Determine workforce characteristics or organisational structure and context (for example organisational design or job analysis to determine behavioural success criteria).

7. PROFESSIONAL PRACTICE

7.1 The Industrial Psychologist should:

- Enhance and/or promote individual, group or organisational well-being and optimal functioning,
- Identify and implement objectives and comprehensive person-orientated interventions that enhance optimal functioning of individuals, groups and organisations such as the implementation of practices that optimise the fit of individuals to jobs, leadership training, conflict resolution, mediation, coaching, career counselling and team development,

- Communicate the results of interventions and research to clients and other appropriate stakeholders taking ethical and confidentiality requirements into consideration,

- Compile reports on the results of assessments and other intervention outcomes,

- Industrial Psychologist observes the regulatory framework, professional standards and codes of ethics and conduct.
