The **CITY OF CAPE TOWN, WATER AND SANITATION: DISTRIBUTION SERVICES**, invites tenders for Tender No. **83Q/2023/24: Term Tender for Laying of New Sewer Mains**

Tenderers must be registered on Supplier Databases as described in the tender conditions.

Tenderers who are not registered on these Databases are not precluded from submitting tenders, but must however be registered upon being requested to do so in writing and within the period contained in such a request.

Tenderers must have a CIDB contractor grading designation of 5CE or higher.

Furthermore, in terms of these Regulations and the SCM Policy, tenderers are required to meet the HDI and/or RDP specific goals
