Tenders are hereby invited from service providers for TD-09/02/2022: TWO WAY RADIO COMMUNICATION SERVICE FOR A PERIOD OF THREE YEARS STARTING 1 JULY 2022 ENDING 30 JUNE 2025.

Formal tenders sealed and clearly marked "TD-09/02/2022: TWO WAY RADIO COMMUNICATION SERVICE FOR A PERIOD OF THREE YEARS STARTING 1 JULY 2022 ENDING 30 JUNE 2025" must be placed in the Municipal tender box, 26 Church Street, OUDTSHOORN no later than 12h00 on 24 MARCH 2022 and will be opened in public immediately thereafter in the Supply Chain Management Office, 26 Church Street, OUDTSHOORN or any alternative place in Oudtshoorn Municipal Offices.

A set of fully completed tender documents must be submitted on the original documents and remain valid for a maximum of 120 days after the closing date of the tender. A set of tender documents can be obtained at a non-refundable cost of **R318-00 including VAT** for hard copies directly printed by the Municipality and free of charge when provided on pdf via e-mail. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation to tender and/or re-advertise or to reject any formal tender or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

Only locally produced or locally manufactured goods with a minimum threshold for local production and content will be considered:

- Two way Radio-60%

The exchange rate used to calculate local production and content must be the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on 17 FEBRUARY 2022

Pre-qualification

 Bidder must have a workshop within a 100 km range from Oudtshoorn and such proof must be provided. If not within 100 km from Oudtshoorn the recommended bidder must establish a workshop in Oudtshoorn on his appointment.

Formal Tender TD-09/02/2022 will be evaluated and adjudicated in terms of the **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2017) and the Municipality's Supply Chain Management Policy. Further note, it is prerequisite that all prospective service providers who are not yet registered on the Central Supplier Database to be registered, registration can be done online via www.csd.gov.za
