T1.1.1: TENDER NOTICE AND INVITATION TO TENDER

The Inner-City Regeneration (ICR) Programme is a flagship initiative led by the City Manager's Office, aimed at transforming Durban's inner city into a well-managed, inclusive, and economically vibrant urban centre. The ICR Programme is structured around 15 strategic workstreams, addressing key focus areas such as housing delivery, safety, public realm management, transport, social infrastructure, economic revitalization, and governance.

The City Manager has approved the appointment of a **Consultant Programme Manager** to provide dedicated leadership, strategic coordination, and operational oversight to accelerate delivery, enhance reporting integration, and strengthen alignment with municipal, provincial, and national priorities.

The Programme Management Team will be responsible for centralised oversight and coordination across all 13 workstreams, ensuring alignment to municipal priorities, timely delivery, effective stakeholder engagement, and optimal use of resources.

T1.2: TENDER DATA

T1.2.1 STANDARD CONDITIONS OF TENDER

The conditions of tender are the Standard Conditions of Tender as contained in Annex F of the CIDB Standard for Uniformity in Construction Procurement (July 2015) as published in Government Gazette No 38960, Board Notice 136 of 2015 of 10 July 2015.

The Standard Conditions of Tender make several references to the Tender Data for details that apply specifically to this tender. The Tender Data shall have precedence in the interpretation of any ambiguity or inconsistency between it and the Standard Conditions of Tender.

T1.2.2 TENDER DATA

Each item of data given below is cross-referenced to the clause in the Standard Conditions of Tender to which it mainly applies.

F.1: GENERAL

F.1.1 The employer: The Employer for this Contract is the eThekweni Municipality as represented by: Deputy Head: **Economic Infrastructure Renewal and Revitalisation**

F.1.2 Tender documents: The Tender Documents issued by the Employer comprise:

- 2) The “Standard Professional Services Contract – 3rd Edition July 2009” published by the Construction Industry Development Board (CIDB). This document is obtainable separately, and Tenderers shall obtain their own copies.
- 3) In addition, Tenderers are advised, in their own interest, to obtain their own copies of the following acts, regulations, and standards referred to in this document as they are essential for the Tenderer to get acquainted with the basics of construction management, the implementation of preferential construction procurement policies, and the participation of targeted enterprise and labour.
 - The Employer’s current (as at advertising date) Supply Chain Management Policy.
 - The Preferential Procurement Policy Framework Act No 5 of 2000, and the Preferential Procurement Policy Framework Act Regulations (2022).
 - The Occupational Health and Safety Act No 85 and Amendment Act No 181 of 1993, and the Construction Regulations (2014).
 - The Construction Industry Development Board Standard for Uniformity in Construction Procurement (July 2015).
 - Any other eThekweni Policy documents referenced in the Tender Documents.

F.1.4 Communication and employer’s agent: The Employer’s Agent’s Representative is:

The Tenderer's contact details, as indicated in the Contract Data: Clause C1.2.2.2 "Data to Be Provided by Contractor", shall be deemed as the only valid contact details for the Tenderer for use in communications between the Employer's Agent and the Tenderer.

F.2: TENDERER'S OBLIGATIONS

F.2.1 Eligibility: General

A Tenderer will not be eligible to submit a tender if:

- (a) the Tenderer submitting the tender is under restrictions or has principles who are under restriction to participate in the Employer's procurement due to corrupt or fraudulent practices.
- (b) the Tenderer does not have the legal capacity to enter into the contract.
- (c) the Tenderer does not comply with the legal requirements as stated in the Employer's current SCM Policy.
- (d) the Tenderer cannot provide proof that he is in good standing with respect to duties, taxes, levies and contributions required in terms of legislation applicable to the work in the contract.
- (e) In the event of a Compulsory Clarification Meeting:
 - i) the Tenderer fails to attend the Compulsory Clarification Meeting.
 - ii) the Tenderer fails to have form "Certificate of Attendance at Clarification Meeting / Site Inspection" (in T2.2) signed by the Employer's Agent or his representative.
- (f) in the case of JV submissions, two or more JV entities have common directors / shareholders or common entities tendering for the same works.
- (g) at the time of closing of tenders, the Tenderer is not registered on the **National Treasury Central Supplier Database** (CSD) as a service provider. In the case of a Joint Venture, this requirement will apply individually to each party in the Joint Venture.
- (h) The tender fails to complete and sign the Declaration of Municipal Fees in T2.2: "Returnable Documents" and submits the required documentation. Reference is to be made to Returnable Document T2.2.12.

SCM Policy (Cl.14(4)) requires suppliers/ service providers/ contractors to be registered on the **eThekweni Municipality Central Supplier Database**.

- (c) Tenderers are to register prior to the submission of tenders.

“Acknowledgement of receipt of the addenda will be by the return of the relevant completed, dated, and signed portion of the addenda, to the physical or email address as specified on the addenda. Failure of the tenderer to comply with the requirements of the addenda may result in the tender submission being made non-responsive.”

F.2.7 Clarification meeting:

In the event of a Compulsory Clarification Meeting, Tenderers must sign the attendance register in the name of the tendering entity. The Tenderer’s representative(s) at the clarification meeting must be able to clearly convey the discussions at the meeting to the person(s) responsible for compiling the entity’s tender offer.

F.2.12 Alternative tender offers: No alternative tender offers will be considered.

F.2.16 Tender offer validity: The Tender Offer validity period is 120 Days from the closing date for

- F.2.23 Certificates:** Refer to T2.1 for a listing of certificates that must be provided with the tender. All certificates must be valid at the time of tender closing.

Tenderers are to include, at the back of their tender submission document, a printout of the required documents/ certificates.

The Form of Offer (C1.1.1), Data to be provided by the Contractor (C1.2.2.2), and the Bill of Quantities (C2.2) are also required to be completed in full.

Tax Clearance

Refer also to returnable form in T2.2.3: "Tax Compliance Status PIN/ Tax Clearance Certificate".

SARS has introduced a new Tax Compliance Status System. Tenderers must submit a **Tax Compliance Status PIN** (TCS PIN) instead of an original Tax Clearance Certificate. This TCS PIN can be used by third parties to certify the taxpayer's real-time compliance status. This TCS PIN is to be entered on Returnable Document T2.2.1: "Compulsory Enterprise Questionnaire". Separate Tax Clearance Certificates / TCS PINs are required for each entity in a Joint Venture.

Failure to comply will make the tender non-responsive.

F.3: THE EMPLOYER'S UNDERTAKINGS

Eligibility

Tenders will be checked for compliance with the ELIGIBILITY requirements, as specified in Clause F.2.1. Tenderers not in compliance will be deemed non-responsive.

Functionality

FUNCTIONALITY will be evaluated to determine the responsiveness of tenders received. The minimum score for **FUNCTIONALITY is 70 points**. Those tenders not achieving the minimum score will be deemed non-responsive.

The functionality Criteria, Sub-Criteria, Points per Criteria/ Sub-Criteria, Returnable Documentation and Schedules, Method of Evaluation, and Prompts for Judgement are as specified in T1.2.3: “Additional Conditions of Tender”.

Preference Point System

The financial offer will be reduced to a comparative basis using the **Tender Assessment Schedule**.

The procedure for the evaluation of responsive tenders is **PRICE AND PREFERENCE** in accordance with the Employer’s current SCM Policy, the Preferential Procurement Policy Framework Act (5 of 2000), and the Preferential Procurement Policy Framework Act Regulations (2022).

Price Points

Targeted Procurement

(SCMP Cl.23) After tender submissions have been evaluated in terms of the **Preference Point System** and the highest points scorer has been ascertained, the requirements of targeted procurement will be applied according to the provisions of the SCM Policy.

Targeted Procurement requirements are specified in the "**Additional Conditions of Tender**" in T1.2.3.4.

F.3.13 Acceptance of tender offer: In addition to the requirements of Clause F.3.13 of the Standard Conditions of Tender, tender offers will only be accepted if:

- The tenderer submits a **valid Tax Clearance Certificate OR Tax Compliance Status PIN**, issued by the TCS System of the South African Revenue Services, or has made arrangements to meet outstanding tax obligations.

The Municipality does not bind itself to accept the lowest or any tender. It reserves the right to accept the whole or any part of a tender to place orders. Bidders shall not bind the Municipality to any minimum quantity per order. The successful Tenderer (s) shall be bound to provide any quantities stipulated in the specification.

F.3.17 Copies of contract: The number of **paper copies** of the signed contract to be provided by the Employer is **ONE (1)**.

Bidders must submit a "hard copy" submission to the Tender Box located in the ground floor foyer of the Municipal Buildings, 166 KE Masinga Road (Old Fort Rd), Durban and an electronic submission via SSS. - 13.5.1 The maximum amount of compensation payable by either Party to the other in respect of liability under the Contract is limited to **R 5 000 000.00.**
- 15 The interest rate will be prime interest rate of the Employers bank at the time that the amount is due.

C1.2.3 ADDITIONAL CONDITIONS OF CONTRACT

The additional conditions of contract are:

C1.2.3.1 PERFORMANCE MONITORING OF SERVICE PROVIDERS

For contract awards that are greater than R10m, the Service Provider shall be subjected to "Performance Monitoring" assessments in terms of the applicable Section of the Council's current Supply Chain Management Policy.

C1.2.3.2 RETENTION

PART C3 : SCOPE OF WORK

C3.1 BACKGROUND

The Inner-City Regeneration (ICR) Programme is a flagship initiative led by the City Manager's Office, aimed at transforming Durban's inner city into a well-managed, inclusive, and economically vibrant urban centre. The ICR Programme is structured around 15 strategic workstreams, addressing key focus areas such as housing delivery, safety, public realm management, transport, social infrastructure, economic revitalization, and governance.

The City Manager has approved the appointment of a **Consultant Programme Manager** to provide dedicated leadership, strategic coordination, and operational oversight to accelerate delivery, enhance reporting integration, and strengthen alignment with municipal, provincial, and national priorities.

The Programme Management Team will be responsible for centralised oversight and coordination across all 13 workstreams, ensuring alignment to municipal priorities, timely delivery, effective stakeholder engagement, and optimal use of resources.

C3.2 EMPLOYER'S OBJECTIVES

The purpose of this appointment is to:

- Provide high-level programme management and technical support to the City Manager, the ICR Lead, and the ICR Core Team.
- Strengthen coordination, reporting, and accountability across all 15 ICR workstreams.
- Ensure full alignment between fiscal reporting (expenditure and budget tracking) and programme reporting (performance and outputs).
- Enhance stakeholder management, accelerate project delivery, and promote private sector participation.

C3.3 SCOPE OF SERVICES TO BE RENDERED

The Consultant Programme Manager will be responsible for the following key activities:

3.1 Programme Coordination and Management

- Oversee the implementation of all ICR workstreams, ensuring timely delivery and alignment with the City's strategic objectives.
- Facilitate inter-workstream coordination to manage dependencies, risks, and bottlenecks.
- Develop and maintain a consolidated ICR Programme Implementation Schedule.
- Convene regular coordination meetings, technical sessions, and strategic reviews across workstreams.
- Drive the development of a consolidated ICR Investment Portfolio to guide sequencing and resource prioritisation.

3.2 Performance and Fiscal Reporting Alignment

- Ensure seamless integration of financial and programme reporting by supporting workstream leads to report on both budget and performance metrics.
- Develop standardised reporting templates that capture fiscal and programme indicators.
- Lead the preparation of consolidated weekly dashboards, monthly and quarterly reports for submission to the City Manager's Office.
- Facilitate performance review sessions with the ICR Core Team and Finance Department.

3.3 Stakeholder Management and Engagement

- Maintain structured and proactive engagement with:
 - City officials across departments
 - Provincial and national government stakeholders
 - National Treasury and World Bank teams
 - Development partners and private sector investors
 - Coordinate workshops, site visits, and plenary forums to strengthen collaboration.
 - Support the communication workstream to ensure the timely dissemination of programme updates to internal and external audiences.

3.4 Strategic Advisory Support

- Provide strategic input on the possible institutionalisation of the ICR Programme, including transitioning to a formal inner-city entity.
- Assist in the development of financing strategies, including public-private partnerships and innovative funding models.
- Ensure alignment with national priorities such as the District Development Model (DDM), the Presidential Support Programme, and the Human Settlements Technical Support Programme (HSTSP).

3.5 Risk Management and Problem-Solving

- Maintain an active risk register, regularly identifying critical risks and mitigation strategies.
- Facilitate the resolution of implementation barriers in collaboration with workstream leads and the ICR Core Team.
- Monitor progress against agreed milestones and ensure corrective actions are implemented promptly.

3.6 Infrastructure Engineer / Built Environment Specialist

- Lead the analysis, assessment, and conceptual design of major built environment interventions—roads, stormwater, public realm upgrades, building refurbishments—within the inner-city regeneration portfolio
- Coordinate across all 13+ workstreams to align infrastructure elements such as road widening, sanitation upgrades, lighting, and surveillance infrastructure for a cohesive public realm.
- Provide guidance on best practices, defend contractual terms, and resolve technical disputes when they arise.
- Ensure adherence to environmental impact assessments and by-laws; liaise with provincial/national regulators for approvals and compliance
- Serve as technical liaison between municipal departments, external consultants, contractors, property owners, and precinct stakeholders.

4. Reporting Lines

The Programme Manager Consultant will:

- Report directly to the **City Manager** or his designated representative.
- Work closely with the ICR Lead, the ICR Core Team, and all workstream leads.
- Provide regular updates to the City Manager's Operations Office Cluster and the City Manager's Support Team.

5. Required Deliverables

The Consultant Programme Manager will be required to submit the following deliverables:

- Inception Report (within 10 working days of appointment)
- Weekly Progress Dashboards (including fiscal and programme updates)
- Monthly Consolidated Progress Reports

- Quarterly Performance Reports aligned with National Treasury and municipal reporting requirements
- Regularly updated ICR Risk Register
- Consolidated Spatial Map of ICR Initiatives
- Two-day site visit coordination report
- Close-out Report at the end of the contract period

6. Duration

The appointment will be for a **period of three (3) years**, subject to annual performance reviews, satisfactory delivery of key outputs, and the availability of funding.

7. Contract Management

The City Manager's Office will manage the contract. Oversight will be provided by the ICR Core Team, with performance monitoring at quarterly intervals.

Annex F
(normative)

Standard Conditions of Tender

F.1 General

F.1.1 Actions

F.1.1.1 The employer and each tenderer submitting a tender offer shall comply with these conditions of tender. In their dealings with each other, they shall discharge their duties and obligations as set out in F.2 and F.3, timeously and with integrity, and behave equitably, honestly and transparently, comply with all legal obligations and not engage in anticompetitive practices.

F.1.1.2 The employer and the tenderer and all their agents and employees involved in the tender process shall avoid conflicts of interest and where a conflict of interest is perceived or known, declare any such conflict of interest, indicating the nature of such conflict. Tenderers shall declare any potential conflict of interest in their tender submissions. Employees, agents and advisors of the employer shall declare any conflict of interest to whoever is responsible for overseeing the procurement process at the start of any deliberations relating to the procurement process or as soon as they become aware of such conflict, and abstain from any decisions where such conflict exists or recuse themselves from the procurement process, as appropriate.

Note:

- 1) *A conflict of interest may arise due to a conflict of roles which might provide an incentive for improper acts in some circumstances. A conflict of interest can arise on appearance of impartiality that can undermine confidence in the ability of that person to act properly in his or her position even if no improper acts result.*
- 2) *Conflicts of interest in respect of those engaged in the procurement process include direct, indirect or family interests in the tender or outcome of the procurement process and any personal bias, inclination, obligation, allegiance or loyalty which would in any way affect any decisions taken.*

F.1.1.3 The employer shall not seek and a tenderer shall not submit a tender without having a firm intention and the capacity to proceed with the contract.

F.1.2 Tender Documents

The documents issued by the employer for the purpose of a tender offer are listed in the tender data.

F.1.3 Interpretation

F.1.3.1 The tender data and additional requirements contained in the tender schedules that are included in the returnable documents are deemed to be part of these conditions of tender.

F.1.3.2 These conditions of tender, the tender data and tender schedules which are only required for tender evaluation purposes, shall not form part of any contract arising from the invitation to tender.

F.1.3.3 For the purposes of these conditions of tender, the following definitions apply:

- a) **conflict of interest** means any situation in which:
- i) someone in a position of trust has competing professional or personal interests which make it difficult to fulfill his or her duties impartially;
 - ii) an individual or organisation is in a position to exploit a professional or official capacity in some way for their personal or corporate benefit; or
