**1.1 DESCRIPTION OF SERVICE: COLD PLASMA UNIT**

**BACKGROUND:** Plasma system is a novel postharvest strategy which is essential to undertake non-thermal treatments for heat sensitive materials. Plasma technology offers solutions for every type of contamination, for every substrate and for every after-treatment. Molecular contamination residues are also broken down in the process. This will be of value to all current projects and new projects. A plasma unit works under atmospheric condition will leads to an increase in quality in production through surface activation and/or cleaning and provide a wide range of application for multidisciplinary research.

**PURPOSE:** Cold plasma which works under atmospheric condition is used in laboratory to decontaminate and modify electrically conductive materials. This unit can be used for pre -treatment of a wide variety of surfaces, such as cleaning and activating to ensure quality, microbial safety, surface morphology, and activation research and development activities. However, coating and inactivation is more effective and the plasma jet with a wide treatment contact range.
