Tenders must be placed in the Municipal Tender Box before 12h00 on **Friday, 31 March 2023** situated at the Supply Chain Management Offices, 11 Lind Street, Swellendam after which tenders will be opened in public. Tenders may only be submitted on the prescribed tender documents and must include the Tax Compliance Status **PIN** as issued by **SARS**.

Late bids and bids received by E-Mail or Facsimile will not be considered. Bids will be evaluated and adjudicated in accordance with the Swellendam Municipality's preferential procurement policy and its Supply Chain Management Policy. The **80/20**-point system will be applicable.

The Municipality reserves the right to withdraw any invitation for tenders and/or to re-advertise or to reject any tender or to accept a part of it. The Municipality does not bind itself to accept the lowest bid or award a contract to the service provider scoring the highest number of points. Subject to the sole discretion of the Municipality, failure to supply all supplementary information and documentation may result in the tender being rendered non-responsive

Special Condition of tender:

- Supplier(s) must have past performance record of similar projects. Provide at least 2 contactable references.
- Supplier(s) to have an operational Filling Station within the Swellendam Municipal area. Alternatively, suppliers who are not based in the Swellendam Municipal area, may provide the municipality with a proposal for a fuel storage facility and submit an offer for the cost associated with the provision of the storage facility (refer to pricing schedule).
