If the service provider damaged the printer, the service provider will replace it with the same HP printer or latest available at the service providers cost.			
If the HP printer 1536dnf, with Serial number CND9D86DM8, is returned in a poor condition or if it is not working like it is supposed to work, due to negligence of the service provider or if incorrect parts was used or parts not being inserted correctly, that's causing malfunction of the printer, the service provider will be held responsible for any cost to repair the HP printer 1536dnf, with Serial number CND9D86DM8, to the same state it was in before it was removed from the ARC's property for the service.			
The service provider must be registered to work on printers such as SITA accredited or equivalent and must provide the ARC with a service warranty of the service and parts that was done/replace on the printer.			

The service provide will stay in contact with the end user – ARC until the printer is returned to the premises of the ARC. The service provider must indicate how long the service will take and indicate when the printer will be returned on the day it is collected to be serviced.
