The briefing session will start punctually, and information will not be repeated for the benefit of prospective respondent joining the meeting late. Transnet encourages all Respondents to attend. Transnet will not be held responsible if any prospective Respondent did not attend the non- compulsory session and subsequently feels disadvantaged as a result thereof.

## 3 PROPOSAL SUBMISSION

Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

## 4 RFP INSTRUCTIONS

- 4.1 Please sign documents [sign, stamp and date the bottom of each page] before uploading them on the system. The person or persons signing the submission must be legally authorised by the respondent to do so.
- 4.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**

- 4.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 4.4 Any additional conditions must be embodied in an accompanying letter. Subject only to clause 15 [Alterations made by the Respondent to Bid Prices] of the General Bid Conditions, paragraph 12 below (Legal Review) and Section 6 of the RFP, alterations, additions or deletions must not be made by the Respondent to the actual RFP documents.

## 5 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture [**JV**] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Transnet through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to Transnet.

- Respondents are to note that for the purpose of Evaluation, a JV will be evaluated based on one consolidated B-BBEE score card (a consolidated B-BBEE Status Level verification certificate) Preference points will be awarded to a bidder for attaining the specific goals requirements in accordance with the table indicated in Section 4.1 of the specific goals Claim Form.

## 6 COMMUNICATION

- 6.1 For specific queries relating to this RFP, an RFP Clarification Request Form should be submitted onto the system and to [tccquotes@transnet.net](mailto:tccquotes@transnet.net) before **12:00 pm on 26 June 2026**, substantially in the form set out in Section 8 hereto. In the interest of fairness and transparency, Transnet's response to such a query will be published on the e-tender portal and Transnet website.
- 6.2 After the closing date of the RFP, a Respondent may only communicate using the noted email, email [tccquotes@transnet.net](mailto:tccquotes@transnet.net) on any matter relating to this RFP Proposal.
- 6.3 Respondents are to note that changes to its submission will not be considered after the closing date.
- 6.4 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFP between the closing date and the date of the award of the business.
- 6.5 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.
- 6.6 Transnet will publish the outcome of this RFP in the National Treasury e-tender portal and Transnet website within 10 days after the award has been finalised. Respondents are required to check the National Treasury e-tender Portal and Transnet website for the results of the tender process. All unsuccessful bidders have a right to request Transnet to furnish individual reasons for their bid not being successful. This request must be directed to the contact email address stated in the SBD 1 form.

## 7 CONFIDENTIALITY

All information related to this RFP is to be treated with strict confidence. In this regard Respondents are required to certify that they have acquainted themselves with the Non-Disclosure Agreement. All information related to a subsequent contract, both during and after completion thereof, will be treated with strict confidence. Should the

need however arise to divulge any information related to this RFP or the subsequent contract, written approval must be obtained from Transnet.

## **8 COMPLIANCE**

The successful Respondent [hereinafter referred to as the **[Service provider]**] shall be in full and complete compliance with any and all applicable laws and regulations.

## **9 EMPLOYMENT EQUITY ACT**

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

## **10 DISCLAIMERS**

Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- 10.1 modify the RFP's Services and request Respondents to re-bid on any such changes;
- 10.2 reject any Proposal which does not conform to instructions and specifications which are detailed herein;
- 10.3 disqualify Proposals submitted after the stated submission deadline [closing date];
- 10.4 award a contract in connection with this Proposal at any time after the RFP's closing date;
- 10.5 award a contract for only a portion of the proposed Services which are reflected in the scope of this RFP;
- 10.6 split the award of the contract between more than one Supplier/Service provider, should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- 10.7 cancel the bid process;
- 10.8 validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;
- 10.9 request audited financial statements or other documentation for the purposes of a due diligence exercise;
- 10.10 not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provided for it;
- 10.11 to cancel the contract and/request that National Treasury place the Respondent on its Database of Restricted Suppliers for a period not exceeding 10 years, on the basis that a contract was awarded on the strength of incorrect information furnished by the Respondent or on any other basis recognised in law;
- 10.12 to award the business to the next ranked bidder, provided that he/she is still prepared to provide the required service at the quoted price, should the preferred bidder fail to sign or commence with the contract within a reasonable period after being requested to do so. Under such circumstances, the validity of the bids of the next ranked bidder(s) will be deemed to remain valid, irrespective of whether the outcome of the tender has been published the outcome of the bid process on the National Treasury e-tender Portal and Transnet website. Bidders may therefore be requested to advise whether they would still be prepared to provide the required Goods at their quoted price.

Note that Transnet will not reimburse any Respondent for any preparatory costs or other work performed in connection with its Proposal, whether or not the Respondent is awarded a contract.

**11 LEGAL REVIEW**

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

**12 SECURITY CLEARANCE**

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Goods/Services and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/ SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

**13 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE**

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Respondents must register on the CSD prior to submitting their bids. Business may not be awarded to a Respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD.

***For this purpose, the attached SBD 1 form must be completed and submitted as a mandatory returnable document by the closing date and time of the bid.***

**14 TAX COMPLIANCE**

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

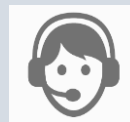
It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations. The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.

## SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

### 1 BACKGROUND/OVERVIEW

#### 1.1. Brief description of the goods or services required and the reason(s) for the proposed acquisition.

- 1.1.1 As one of South Africa's largest property owners, Transnet property supports the government's initiative to sustain revenue generation to support the economy. Security services across all Transnet's various properties are an integral part of securing and safeguarding the assets, ensuring that elevated levels of revenue generation are sustained, by minimizing disruptions that result in incidents such as housebreaking, damage to property, threats to employees and tenants, cable theft, land grab, theft of property, etc.
- 1.1.2 Transnet Property's (TP) objective is to appoint security service providers who are capable of identifying and mitigating security risks through the deployment of competent Security Officers to maximise the protection of TP personnel, contractors, and visitors to TP sites and facilities. TP requirements in respect of national security services include the following:
- 1.1.2.1 Security personnel (Grade A, Grade B, Grade C, Grade C DH2 (dog handlers))
  - 1.1.2.2 Level 2 trained dogs.
  - 1.1.2.3 Vehicles, quads and motorcycles.
  - 1.1.2.4 Security equipment
- 1.1.3 TP seeks to appoint security service providers that hold valid registration with the Private Security Industry Regulatory Authority (PSIRA).

### 2 SCOPE OF REQUIREMENTS

#### 2.1 Provide a detailed overview of the type of services required and reason for the appointment of the service provider(s).

- 2.1.1 Transnet Property (TP) is seeking to acquire services of a suitably registered, qualified, experienced Security Management Company/ies to provide physical security services to ensure protection of TP personnel, contractors, and visitors to TP sites, TP vacant land, any TP assets as well as facilities in compliance with legislative requirements relating to the Private Security Industry Regulation Act, 56 of 2001, and other legislative requirements.
- 2.1.2 The Service Provider should be PSIRA registered, qualified, and experienced in the provision of security services to safeguard the Transnet Property assets including but not limited to buildings, material and employees, including visitors and Service Providers.
- 2.1.3 The security services shall be rendered to Transnet Property Various sites in the following regions:
- Inland Region
  - Northern Region
  - KwaZulu Natal Region
  - Eastern Cape Region
  - Western Cape Region

TP will appoint one (1) qualifying service provider per region for the provision of national security services for a period of twelve (12) months. Prospective bidders may bid for one or more regions and must take note that bidding for a region includes properties associated with the respective regions. There is a need to ensure that Transnet Properties property always remains protected. The properties will be at risk without security officers, thus leaving the properties open for vandalism, theft, illegal occupation and trespassing.

Service providers must indicate the region they are bidding for by completing **Annexure A**: Template indicating the region selection.

### 3 High level scope of work/requirements

- 3.1 Physical access and egress control at all Transnet Property sites across five (5) regions — Inland, Northern, Western Cape, KZN, and Eastern Cape — on a 24-hours-a-day, 7-days-a-week basis, including public holidays.
- 3.2 Deployment of security personnel in the following grades:
  - 3.2.1 Grade A Site Controllers (Monday to Friday, dayshift).
  - 3.2.2 Grade B Site Supervisors and Roving Supervisors (dayshift and nightshift).
  - 3.2.3 Grade C unarmed and armed Security Officers (dayshift and nightshift).
  - 3.2.4 Grade C Dog Handlers DH2 with Level 2 trained dogs.
- 3.3 Provision and maintenance of security equipment including:
  - 3.3.1 Push-to-Talk radios with patrol monitoring, 4G video, location sharing, and 24-hour battery life.
  - 3.3.2 Push-over Cellular smartphones supporting PoC calls, Android apps, and LTE/Wi-Fi switching.
  - 3.3.3 Access Control Scanners compliant with POPIA for real-time ID/barcode scanning.
  - 3.3.4 Single-cab vehicles (branded), quad bikes, and motorcycles for roving patrols — maintained, roadworthy, comprehensively insured, and exclusively used for TP security operations.
  - 3.3.5 SABS-approved handcuffs, batons, torches/spotlights, pepper spray, and breathalysers.
  - 3.3.6 Guard houses, base radios, and portable toilets where applicable.
- 3.4 Conduct of quarterly site-specific security risk assessments across all regions, inclusive of risk identification, mitigation measures, probability and consequence ratings, and tolerance matrix reporting.
- 3.5 Submission of monthly written reports, flash/incident reports (within the same shift), and detailed investigative reports within 12 hours of each incident.
- 3.6 Off-site supervisor visits at a minimum frequency of two (2) visits per shift (before noon and after 15:00 for day shifts; before 00:00 and after 03:00 for night shifts).
- 3.7 Provision of ad hoc security services as and when required due to emergency, operational needs, or unforeseen circumstances, subject to Employer approval. The service will be needed when there is an end to a lease agreement and tenants vacating buildings without notice and evictions due to nonpayment. Task orders are issued, by the building supervisors and approved by the operational manager which will be issued to the Security supervisors to be issued to the supplier. On completion of the work a signed invoice is issued to finance for payment processing.

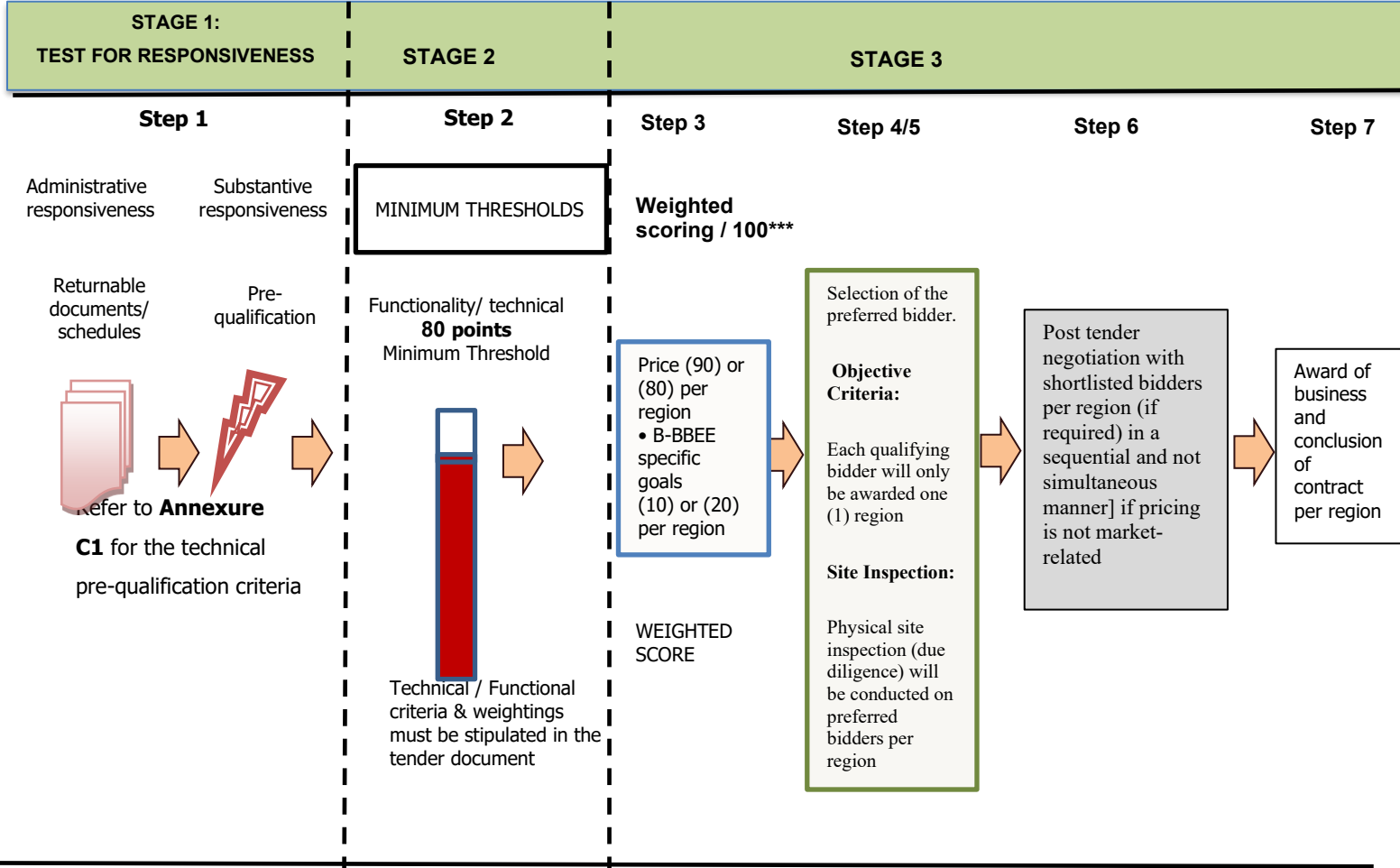

**6.4 STEP FOUR: Objective Criteria (if applicable)**

Transnet reserves the right to award the business to the highest scoring bidder/s unless objective criteria justify the award to another bidder. The objective criteria Transnet may apply in this bid process include:

6.4.1 All risks identified during a risk assessment exercise/ probity check that would be done to assess all risks, including but not limited to:

- The financial stability of the bidder based on key ratio analysis, which would include, but not be limited to Efficiency, Profitability, Financial Risk, Liquidity, Acid Test, and Solvency;
- The identification of conflict of interest; and
- Reputational and Brand risks.

6.4.2 Transnet will award the tender to the highest scoring bidder/s unless objective criteria exist that justify the award to another bidder. Transnet may apply the objective criteria in this bid process as follows:

- Bidder(s) is not in good standing with Transnet due to a poor track record

of past performance with Transnet SOC Ltd and or Transnet Property;

- There is clear, uncontrived and/or overwhelming evidence and/or facts that the bidder has or continues to be in breach of any of the provisions contained in the Integrity Pact;
- The Probity check undertaken by Transnet Property establishes the existence of any unmitigated risks which would have a negative impact on the project; Unless the appointment of the bidder would result in a negative impact on Transnet's Return on Investment;
- It is necessary to rotate Suppliers to promote opportunities for other suppliers, in circumstances where the bidder has been awarded business previously and the award of the tender will result in inequitable allocation of business;
- The tenderer or its members, directors, partners:
  - Is under restrictions as contemplated in the Integrity Pact,
  - Is a subject of a process of restriction by Transnet or other state institution that Transnet may be aware of and there is a clear, uncontrived and/or overwhelming evidence and/or facts in relation to the alleged wrongdoing on the basis of which the restriction process has been initiated;
- In relation to the proposed contract, a due diligence exercise to validate the bidder's proposal that demonstrate that it possesses the professional and technical qualifications, professional and technical competence, financial resources, equipment and other physical facilities, managerial capability, reliability, experience and reputation, expertise and the personnel, to perform the contract;
- Has no legal capacity to enter into the contract;
- Is insolvent, in receivership, under Business Rescue as provided for in chapter 6 of the Companies Act, 2008, being wound up, has its affairs administered pursuant to a court order, has ceased or suspended their business activities, or is subject to legal proceedings in respect of any of the foregoing;
- Does not comply with the legal requirements, if any, stated in the tender data; and
- Is not able to perform the contract free of conflicts of interest.

6.4.3 To mitigate the risk of termination of contracts/ business continuity affecting more than one region, the award of business will be done per region to a qualifying bidder (only one bidder per region), with the sequence of award being from the highest region value to the lowest region value where the bidder scored the highest points for Preference Point System in more than one region.

- The **first** sequenced award will be made for a region with the highest value where the highest scoring bidder achieved the highest points for price and B-BBEE specific goals.
- The **second** sequenced award will be made to the second highest scoring bidder, should the first highest scoring bidder have been awarded a region with the highest region value. In such an instance the award will be made to the second highest ranked bidder.
- The **third** sequenced award will be made to the highest ranked bidder, subject to the highest ranked bidder not been awarded the first or second sequenced award. In such instances the award will be made to the next ranked bidder that is neither the bidder whom the first or

second sequenced award were made.

- The **fourth** sequenced award will be made to the highest ranked bidder, subject to the highest ranked bidder not been awarded the first, second or third sequenced award. In such instances the award will be made to the next ranked bidder that is neither the bidder whom the first, second or third sequenced award were made.
- The **fifth** sequenced award will be made to the highest ranked bidder, subject to the highest ranked bidder not been awarded the first, second, third or fourth sequenced award. In such instances the award will be made to the next ranked bidder that is neither the bidder whom the first, second, third or fourth sequenced award were made.

#### 6.5 **STEP FIVE: Physical Site Inspection**

Transnet will conduct the physical site inspection of the highest ranked bidders who have passed all evaluation stages per region. Bidders must meet all the requirements of the physical site inspection. The requirements for the physical site visit are attached hereto as **Annexure D**.

Bidders will be given a period of fourteen (14) calendar days to ensure preparedness of an office that is operational and functional within the region where the services will be rendered. A valid proof of lease agreement or ownership of the offices that will be visited must be made available during the site visit. Failure to set up an office that is operational and functional, will result in disqualification.

#### 6.6 **STEP SIX: Post Tender Negotiations (if applicable)**

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
  - first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
  - negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

#### 6.7 **STEP SEVEN: Award of business and conclusion of contract**

Empowerment Act, 2003 (Act No. 53 of 2003);

- (g) **"EME"** means an Exempted Micro Enterprise as defines by Codes of Good Practice under section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (h) **"functionality"** means the ability of a bidder to provide goods or services in accordance with specification as set out in the bid documents
- (i) **"Price"** includes all applicable taxes less all unconditional discounts.
- (j) **"Proof of B-BBEE Status Level of Contributor"**
  - i) the B-BBEE status level certificate issued by an authorised body or person;
  - ii) a sworn affidavit as prescribed by the B-BBEE Codes of Good Practice; or
  - iii) any other requirement prescribed in terms of the B-BBEE Act.
- (k) **"QSE"** means a Qualifying Small Enterprise as defines by Codes of Good Practice under section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 ( Act No. 53 of 2003);
- (l) **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties.
- (m) **"Specific goals"** means targeted advancement areas or categories of persons or groups either previously disadvantaged or falling within the scope of the Reconstruction and Development Programme identified by Transnet to be given preference in allocation of procurement contracts in line with section 2(1) of the PPPFA.

### 3. POINTS AWARDED FOR PRICE

#### 3.1 THE 90/10 or 80/20 PREFERENCE POINT SYSTEMS

A maximum of 90 or 80 points is allocated for price on the following basis:

- 4.5 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contract more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME or a QSE that is 51% Black Owned and that has the capability and ability to execute the sub-contract.
