South African Postbank has been contracted by the South African Social Security Agency (SASSA) to provide dignity services at cash pay points and SAPO branches and pay out beneficiaries eligible for the grant.

2. Objective

To appoint a Dignity Service provider to deliver Toilets, Tents, Tables, Chairs, Wheelchairs, Water dispensers and Disposable Glass for KwaZulu Natal Province per Area and per Branch including Cash Pay Points on a month to month basis as and when required.

1.5 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.
