## PART 1: INVITATION TO TENDER

### 1 GENERAL

Submissions to this Request for Proposal (RFP) [hereinafter referred to as a Tender or a Proposal] are requested from persons, companies, close corporations or enterprises [hereinafter referred to as an entity, or Tenderer].

#### 1.1 DESCRIPTION

RFP number SFF/2024/NOE/SP5 is for a technical Tenderer, referred to as the Tenderer in this tender document, to Carry Out Sub-Project#5 Comprising a 2D Seismic Survey Design and Seismic Modeling for the Jonglei Sub-basin in Block B2 of South Sudan.

#### 1.2 ISSUE AND COLLECTION DATE DEADLINE

This RFP may be downloaded directly from National Treasury's e-Tender Publication Portal at [www.etenders.gov.za](http://www.etenders.gov.za) free of charge.

## 3 **BROAD-BASED BLACK ECONOMIC EMPOWERMENT AND SOCIO-ECONOMIC OBLIGATIONS**

SFF Association fully endorses and supports the Government's objective of Broad-Based Black Economic Empowerment and it is strongly of the opinion that all South African business enterprises have an equal obligation to redress the imbalances of the past.

### 3.1 B-BBEE Joint Ventures or Consortiums

Tenderers who would wish to respond to this RFP as a Joint Venture [JV] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Tenderers must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If such a JV or consortium agreement is unavailable, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by SFF association through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to SFF Association.

### 3.2 Preference Points and Specific Goals

As prescribed in terms of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000 and Preferential Procurement Regulations 2022, Tenderers are to note that the following preference point systems:

- **the 80/20 system for requirements with a Rand value of up to R50,000,000 (all applicable taxes included) OR**
- **the 90/10 system for requirements with a Rand value above R50,000,000 (all applicable taxes included)**

When SFF association invites prospective Service Providers to submit Proposals for its Specific Goals, it requires Tenderers to complete Annexure A [the B-BBEE Preference Point Claim Form] and submit it together with proof of their documents as stipulated in the Claim Form in order to obtain Specific Goal Points.

**Note:** Failure to submit a valid and certified copy B-BBEE certificate or Sworn Affidavit or any other documents specified (as evidence for Specific Goals) at the Closing Date of this RFP will result in a score of zero being allocated for Specific Goals.

### 3.3 Subcontracting

SFF association fully endorses Government's transformation and empowerment objectives when contemplating subcontracting. Tenderers are requested to give preference to companies which are, Entities with a specified BEE level, EMEs and QSEs, and South African Owned Companies in order to promote Supplier Development.

In terms of Annexure A of this RFP [the B-BBEE Preference Point Claim Form], Tenderers are required to indicate the percentage of the contract that will be sub-contracted as well as the B-BBEE status of the sub-contractor/s.

In addition, tenderers are required to attach a letter from the intended sub-contractor in the event of the Tenderer's appointment.

- 4.2 Any correspondence with regards to this RFP must be in writing to the provided email address only.
- 4.3 After the closing date of the RFP, a Tenderer may only communicate with the Procurement Unit, specific person for this RFP on any matter relating to its RFP.
- 4.4 Tenderers are to note that changes to its submission will not be considered after the closing date.
- 4.5 Tenderers are warned that a proposal will be liable to disqualification should any attempt be made by a Tenderer either directly or indirectly to canvass any officer or employee of SFF in respect of this RFP between the closing date and the date of the award of the business.
- 4.6 Furthermore, Tenderers found to be in collusion with one another will be automatically disqualified and restricted from doing business with SFF in the future.

## **5 INSTRUCTIONS FOR COMPLETING THE RFP**

- 5.1. Proposals must be submitted in digital electronic format via the National Treasury online eTender Portal ([www.etenders.gov.za](http://www.etenders.gov.za)).
- 5.2. All returnable documents tabled in the Proposal Form [Part 5] must be returned with your proposal.
- 5.3. Unless otherwise expressly stated, all proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.

## **6 COMPLIANCE**

The successful Tenderer shall be in full and complete compliance with any and all applicable laws and regulations.

## **7 DISCLAIMERS**

Tenderers are hereby advised that SFF is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that SFF reserves the right to:

- 7.1. modify the RFP's Scope of Work and request Tenderers to re-tender on any such changes;
- 7.2. reject any Proposal which does not conform to instructions and scope of work which are detailed herein;
- 7.3. disqualify Proposals submitted after the stated submission deadline [Closing Date];
- 7.4. not necessarily accept the lowest priced Proposal or an alternative Tender;
- 7.5. validate any information submitted by Tenderers in response to this tender. This would include but not limited to, requesting the Tenderer to provide supporting evidence. By submitting a tender, the Tenderer hereby irrevocable grant the necessary consent to SFF to do so;
- 7.6. request audited financial statement or other documentation for the purposes of a due diligence exercise;

Tenderers may therefore be requested to advise whether they would still be prepared to provide the required Services at their quoted price, even after they have been issued with a Letter of Regret.

Kindly note that SFF association will not reimburse any Tenderer for any preparatory costs or other work performed in connection with its Proposal, whether or not the Tenderer is awarded a contract.

## **8 LEGAL REVIEW**

A Proposal submitted by a Tenderer will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by SFF Legal Advisor, prior to consideration for an award of business.

## **9 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE**

Tenderers are required to self-register on National Treasury's Central Supplier Database ("CSD") which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Tenderers must register on the CSD prior to submitting their bids. Business may not be awarded to a Tenderer who has failed to register on the CSD. **Only foreign suppliers with no local registered entity need not register on the CSD.**

**For this purpose, the attached SBD1 form must be completed and submitted as a returnable document by the closing date and time of the bid (ANNEXURE E).**

## **10 TAX COMPLIANCE**

Tenderers must be compliant when submitting a proposal to SFF and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this tender that the tax matters of the successful Tenderer be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Tenderer's tax obligations.

The Tax Compliance status requirements are also applicable to foreign Tenderers who wish to submit tenders.

Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

## **11 PROTECTION OF PERSONAL INFORMATION ACT, NO.4 OF 2013**

SFF association acknowledges that the Tenderer may be required to process the personal information of SFF association and other relevant data subjects in connection with and for the purposes of this RFP.

The Tenderer shall–

- (a) only process such personal information for the purpose connected with this RFP, except to the extent specifically requested to do otherwise by SFF association in writing or required by the Protection of Personal Information Act, No.4 of 2013 (POPI) or other applicable laws;
- (b) comply with all directions and instructions which may be given by SFF association regarding the processing of such personal information;
- (c) only process personal information strictly in compliance with POPI;

## PART 2. BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

### 12 BACKGROUND AND SCOPE OF WORK

#### 12.1 Introduction

RFP number SFF/2024/NOE/SP5 is for a Tenderer, referred to as the Tenderer in this document, to carry out a soil survey referred to as ‘**Sub-Project5: 2D Seismic Survey Design and Seismic Modeling for the Jonglei sub-basin in Block B2, South Sudan**’.

An Exploration and Production Sharing Agreement (EPSA) was co-signed between A South Africa’s state-owned Strategic Fuel Fund (“SFF”) and South Sudanese government, on the 6<sup>th</sup> May 2019. Under this agreement, SFF will conduct exploration activities (airborne gravity-magnetic survey, 2D seismic, drilling wells, etc.) in Block B2 alongside South Sudan’s national oil company, Nile Petroleum Corporation.

As part of fulfilling the obligations planned for the current year (2024), SFF requires the technical service of a contractor to carry out a 2D seismic survey design and seismic modelling study. This sub-project main goal is ensuring data quality optimization while minimizing capital expenditure and environmental impact.

#### 12.2 Background Information

SFF has mandated the Exploration and Production (E & P) department to implement a technical work program and initiate the procurement processes to enable the fulfilment of the EPSA responsibilities according to the scheduled commitments. The collection of 2D seismic data in the exploration area is part of the EPSA agreement mandate to be acquired after executing the gravity-magnetic survey and Environmental Social Impact Assessment (ESIA) study in Block B2, to optimize the acquisition according to the results achieved.

This seismic survey will assist to define the structural architecture and shall be used: (a) To improve imaging at different stratigraphic levels thereby optimizing drilling locations and development of the area, (b) To classify and map major and minor faults at shallow / deep exploration targets, (c) To characterize the reservoir (DHIs).

The 2D seismic survey is planned to an area of interest that covers approximately 6000 sq.-km. The reservoir level is postulated to be at a depth of 2400-3200 m.

Geologically, the study area (Block B2) is in the southern part of Muglad Basin (Jonglei Sub-basin), a large rift basin related to the Central African Rift system and its Africa Shear Zone (CASZ).

Block B2 depo-centres remains unexplored, and its geology and oil potential are assumed to be an extension of the main basin. The depo-centres of Muglad Basin as the ones in Block B2 are known to contain Cretaceous to Paleogene lacustrine and marine source rocks that have generated hydrocarbons since the Late Cretaceous. The generated hydrocarbons migrated into Cretaceous and Paleogene reservoirs and structural traps.

Three stratigraphic units: Aradeiba, Bentiu and Abu Gabra are recognised from analogous fields in Muglad basin as potential reservoirs, being Bentiu as the main producing reservoir target. All these stratigraphic units including the basement are the main focus of interest in the scope of work for this project.

The target surface location displays a variety of terrains ranging from flood plains to transition zones to swampy areas. This diversity represents a challenge in the planning and identification of optimal survey parameters and specifications (source and receivers' type, etc.) thereby magnifying the role of this project and its importance in effectively overcoming the challenges.

### **12.3 Objectives**

Seismic data acquisition methods are valuable tools for delineating possible oil and gas reservoirs in the sub-surface. The first stage in seismic acquisition is the planning of the survey parameters which includes program design and seismic modelling and is based on a wide variety of geophysical, operational, and cost constraints.

The objective of this study is to provide an unbiased, comprehensive, and cost-effective survey design and analysis to determine the optimal parameters for the 2D seismic survey to achieve SFF's geophysical goals. The main 3 goals are: (1) to enhance data quality in terms of S/N and resolution, (2) to improve imaging at different stratigraphic levels for its proper mapping (closure) and for major and minor faults, and (3) to recover all useable and required data (Far offset) exceeding 40° to attempt to characterize prospective zones.

The final proposed parameters should maximize SFF's return on its seismic investment in Block B2, South Sudan.

### **12.4 Scope of Work**

All aspects (analysis, deliverables, etc.) concerned with the execution of a 2D survey design program and seismic modeling in Block B2, South Sudan, includes but are not limited to:

- Seismic parameters survey design
- Synthetic seismic modelling
- Surface exclusion modelling
- Reporting and presentation of outcomes and recommendations, including cost optimization of design parameters.
- Assisting in the preparation of the technical aspects of seismic acquisition (sub-project#6) scope of work, including requirements for parameters and equipment documentation.

## 13 PROJECT EXECUTION PLAN

The Project Execution Plan (PEP) is the plan that defines how this seismic program design and seismic modelling study in Block B2 will be undertaken. it will detail the specific activities in the project, the resources applied to the project, and the organization of the project. The major elements of a project execution plan are:

- Scope Definition
- Project Scheduling
- Timelines as per deliverables (Milestones)
- Resource allocation

Tenderer must submit this as part of the proposal.

## 14 SURVEY DESCRIPTION

### 14.1 Location and Terrain

The survey is located in Jonglei, South Sudan. A location map is provided in figure #1. The terrain is relatively flat. However, 70% of the area is low-lying ground adjacent to the White Nile River (floodplains). This area consists mainly of river sediments and is subject to flooding depending in the rainfall season. The remaining 30% is covered by forested wetlands (swamp)

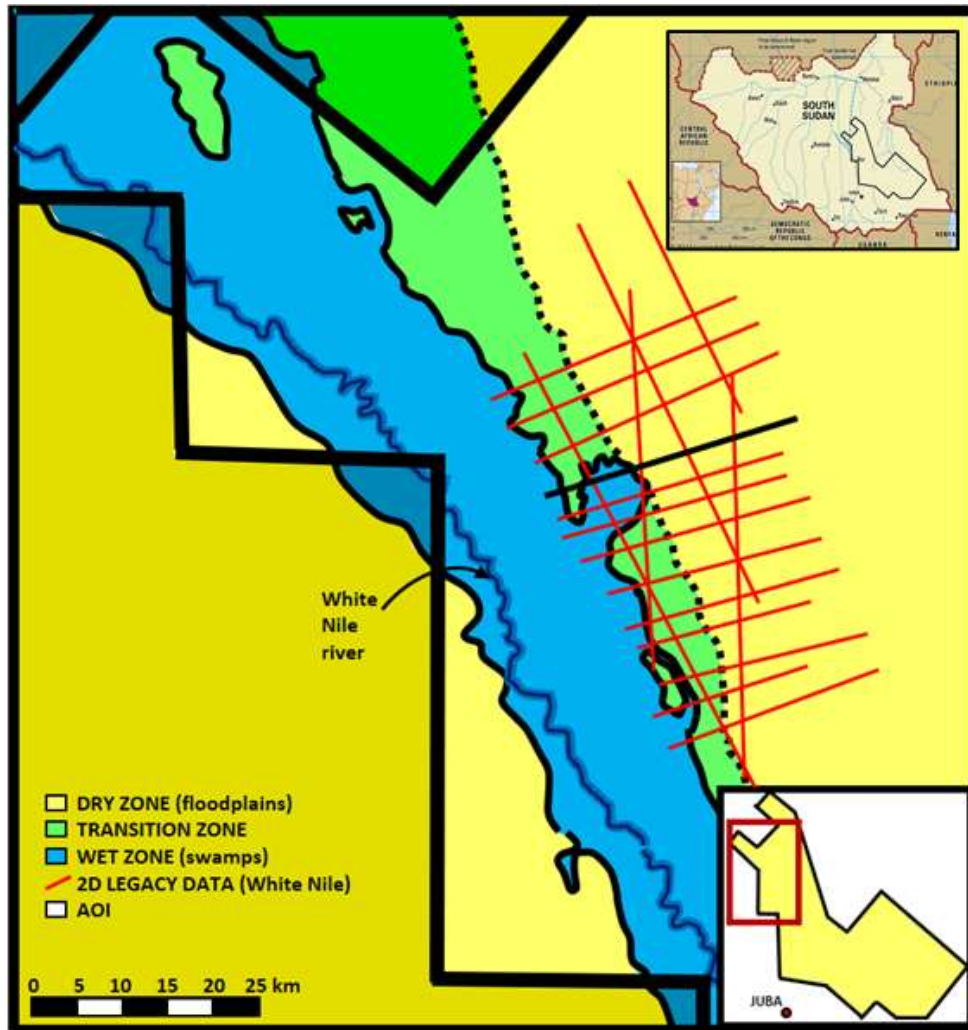


Figure #1: Physiographic zones map (area of interest), including the legacy 2D seismic lines acquired in 2006.

## 14.2 Scouting of Survey Area

Technical service provider must have at its disposal updated high resolution satellite images to procure relevant information regarding the existing infrastructure and topographical constraints in the proposed area where the 2D seismic survey is planned in Block B2, South Sudan. The inspection of images will serve as an input for the surface exclusion modelling (Figure#2).



Figure #2: Satellite image of a portion of the area that will be covered by the 2D seismic survey. The survey inspecting will serve to determine obstacles of natural and man-made origin. These obstacles must be considered in the final shooting plan.

## 14.3 2D Seismic Work Plan

Block-B2 tentative 2D seismic work plan to conduct the surface exclusion model is comprised by 23 lines (dip-strike direction) deployed in the area of interest. Some of those lines intersect a variety of terrains. See figure #3

# 15 2D SEISMIC SURVEY DESIGN AND SEISMIC MODELING TECHNICAL WORK DESCRIPTION, SPECIFICATIONS, AND DATA ANALYSIS

## 15.1 Technical Work Description

The technical service provider will assist SFF from the initial conception of the seismic survey program, through the survey pre-planning. The technical work is made up of 3 stages:

- Seismic Survey Design
- Synthetic Seismic Modelling
- Surface Exclusion Modelling

### 15.1.1 Seismic Survey Design

Technical service provider will determine the optimum parameters to meet SFF geophysical and economic objectives by analysing well data, and existing seismic data quality. The analyses to accomplish in this stage are:

- Spatial aliasing analysis
- Signal to Noise analysis
- Far offset analysis
- 2D Ray Tracing: Far Offset >40° required (\*)
- 2D Fold, Fold Taper / Migration Aperture Analysis
- Fold Analysis
- Near Surface / Source Analysis: Weathering analysis / Ghosting analysis
- Cost optimization of design parameters analysis

(\*) Sensitivity analysis in the modelling is required to determine to what extent does variation in overlying velocities impact the maximum useful angle that will be reflected.

### 15.1.2 Synthetic seismic modelling

Finite Difference, a numerical method to model wave propagation will be used to compute synthetic seismic sections to test the impact of key parameters on the seismic response and to covalidate outcomes from seismic survey design (section 15.1.1).

Key parameters models include, but are not limited to:

- Source intervals
- Receiver intervals
- Far offset
- Near offset
- Seismic frequency

The input data for the synthetic modeling will come from parameters designed on section 15.1.1

The tenderer should provide an opinion or suggestion of an optimal orientation of the lines if any to better imaging the horizons of interest and faults based on the modeling analysis.

### 15.1.3 Surface Exclusion Modelling (Source / Receiver point optimization)

The technical service provider will generate a survey pre-plan of source and receiver including movement locations taking all relevant challenges as topography avoidance, exclusions, and other surface obstacles into consideration:

- Safety considerations (steep terrain and water bodies avoidance)
- Environmental restrictions (existing cut lines, riparian areas, wildlife sensitive areas, national parks, etc.)
- Government regulations (pipelines and water well set-backs)
- Landowner considerations (lockouts – full lockout or receiver only)
- Surface Ground conditions:
  - In this project there will be equipment limitations attributed to varying surface constraints (high lands, transition zone, marsh/swamp, water (lake, river))
- All sources and receivers must be moved accordingly for regulatory compliance and optimize for operations.
- All existing trails/roads must be utilized to minimize environmental impact (if applicable)
- All surface exclusion modelling options shall include a detailed review recommending source type, sensor type that will be appropriate for the environmental conditions present.



The main goal of the survey preplanning is ensuring data quality optimization while minimizing capital expenditure and environmental impact.

- Near offset fold
- Near stack - Far stack fold
- Source and receiver types, parameters, arrays and strategy to overcome environmental surface constraints.
- Parameter Sheet (# shots, # receivers, # stations, # channels, source-receiver interval, etc.) per each option
- Cost estimation scenarios based on parameters above. At least three different scenarios of 2D acquisition parameters options must be provided for comparison.
- Large scale grid pre-plot map, including source-receiver points, satellite imaging, topography, etc.

### 16.2 Synthetic seismic modelling

The tenderer will deliver a series of synthetic seismic models varying key parameters that include:

- Acoustic vs Elastic model
- Seismic frequency comparison – Using 15Hz and 25Hz
- Source intervals comparison – using outcomes from section 15.1.1
- Receiver intervals comparison – using outcomes from section 15.1.1
- Far offset comparison – using offsets determined from Ray tracing component
- Near offset comparison
- Survey arrays – Using spread-split vs End-of-survey comparison – 2500m, 4000m offset.

The comparison scenarios of each modelled parameter will support and validate design parameters outcomes and demonstrate how key parameters impact the ability to image the most relevant subsurface features.

SEGY of final synthetic seismic sections must be available as part of the deliverables list.



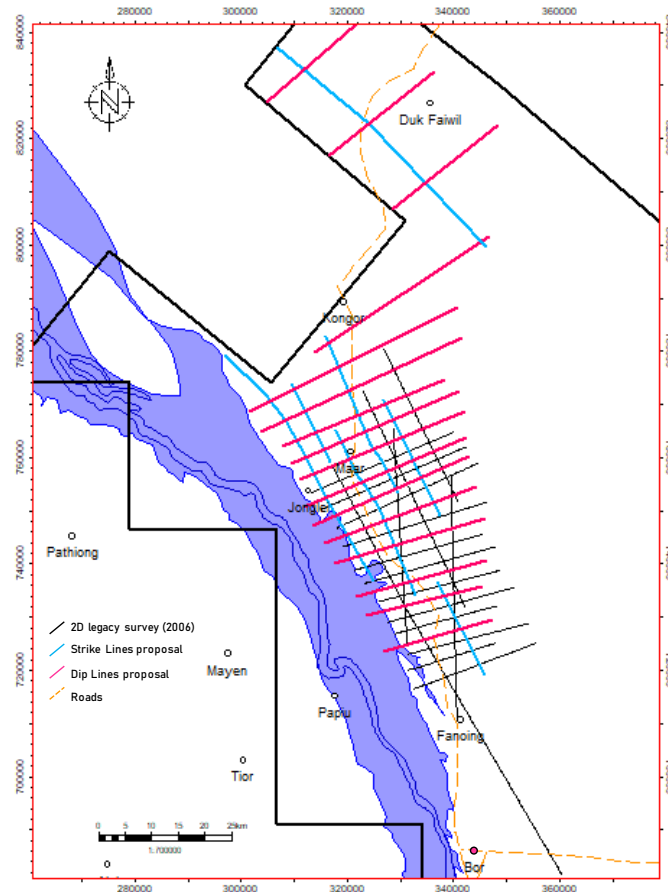


Figure #3: Tentative 2D Seismic layout map

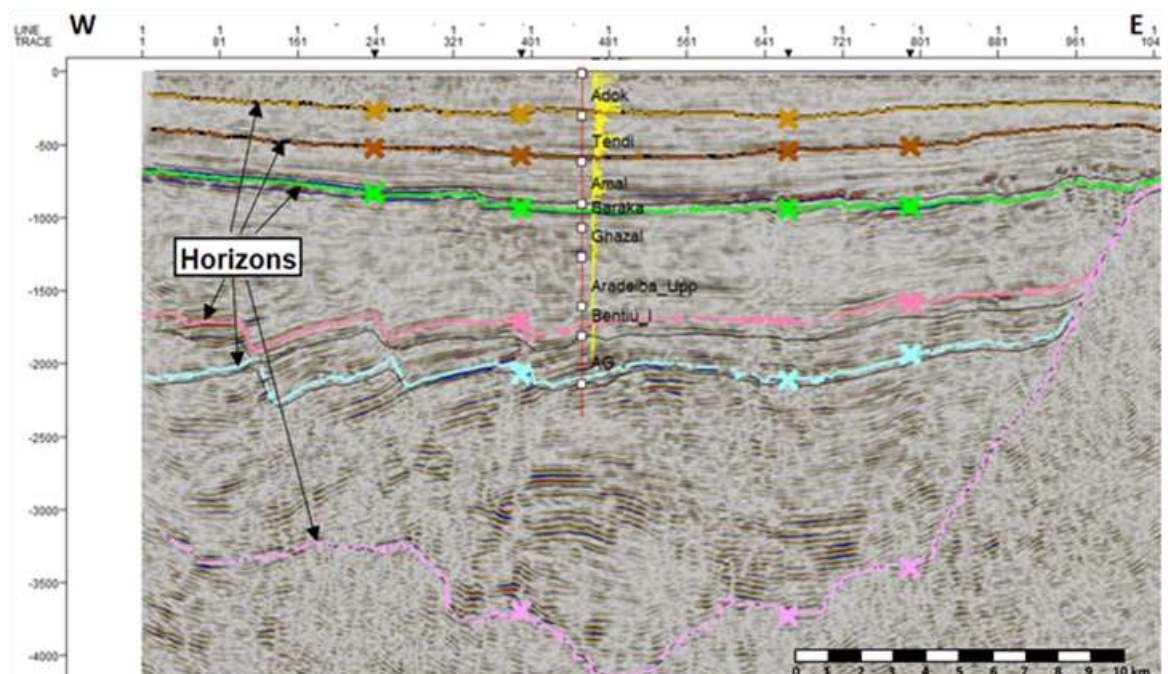

The tenderer will provide a comprehensive visual analysis of the impact of real-world obstructions (topography, infrastructure, environmental restrictions) and how they impact the model from a statistical comparison. Section deliverable but not limited to:

- SEGP1 or SPS and RPS for each 2D surface exclusion modelling options.

The technical service provider will also provide a detailed source-receivers analysis showing the different types that are appropriated to specific ground conditions.

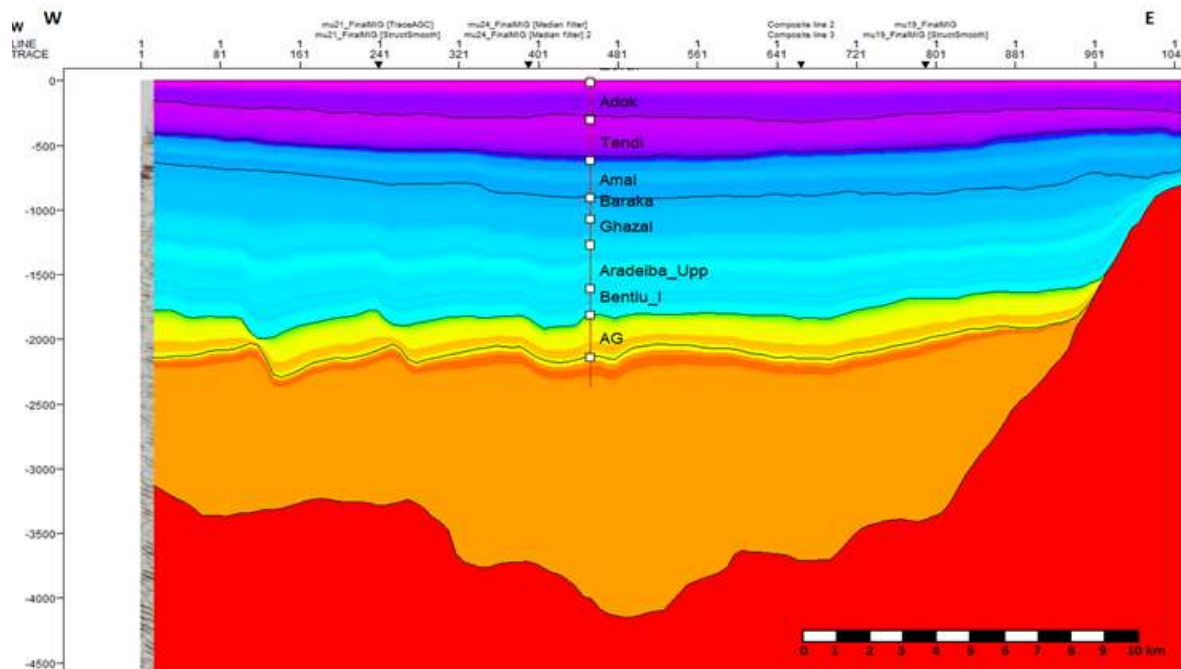


Figure # 5: Interval velocity section (black line in figure #1) generated using velocity data from wells in vicinity field.

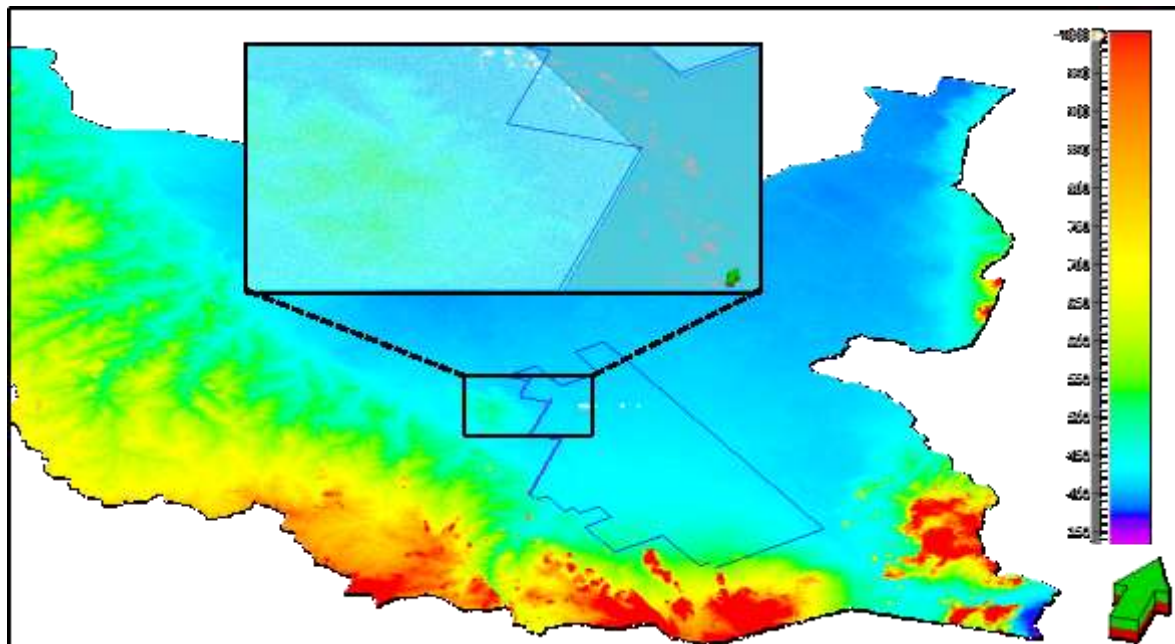

- Any other relevant information

## APPENDIX (III): SAFETY ARRANGEMENTS AND PROCEDURAL COMPLIANCE WITH THE OCCUPATIONAL HEALTH AND SAFETY ACT (ACT 85 OF 1993) AND APPLICABLE REGULATIONS

### 1. General

- 1.1 The Contractor and SFF (hereinafter referred to as “the Client”) are individual employers, each in its own right, with their respective duties and obligations set out in the Occupational Health and Safety Act, Act 85 of 1993 (the Act) and applicable Regulations.
- 1.2 The Contractor accepts, in terms of the General Conditions of Contract and in terms of the Act, his obligations as an employer in respect of all persons in his employ, other persons on the premises or the Site or place of work or on the work to be executed by him, and under his control. He shall, before commencement with the execution of the contract work, comply with the provisions set out in the Act, and shall implement and maintain a Health and Safety Plan as described in the Construction Regulations, 2003 and as approved by SFF, on the Site and place of work for the duration of the Contract.
- 1.3 The Contractor accepts his obligation to complying fully with the Act and applicable Regulations notwithstanding the omission of some of the provisions of the Act and the Regulations from this document.
- 1.4 SFF accepts, in terms of the Act, its obligations as an employer of its own employees working on or associated with the site or place of work, and the Contractor and Procurement Manager / SHEQ Manager / Technical Manager or his deputy shall at all times, co-operate in respect of the health and safety management of the site, and shall agree on the practical arrangements and procedures to be implemented and maintained during execution of the Works.
- 1.5 In the event of any discrepancies between any legislation and this specification, the applicable legislation will take precedence.

### 2. Definitions

- 2.1 In this Specification any word or expression to which a meaning has been assigned in the Construction Regulations, shall have the meaning so assigned to it, unless the context otherwise indicates: -
- 2.2 **“competent person”** in relation to construction work, means any person having the knowledge, training and experience specific to the work or task being performed:  
Provided that where appropriate qualifications and training are registered as per the South African Qualifications Authority Act, 1995 these qualifications and training shall be deemed to be the required qualifications and training;
- 2.4 **“contractor”** means principal contractor and **“subcontractor”** means contractor as defined by the Construction Regulations, 2003.
- 2.5 **“fall protection plan”** means a documented plan, of all risks relating to working from an elevated position, considering the nature of work undertaken, and setting out the procedures and methods applied to eliminate the risk;
- 2.6 **“health and safety file”** means a file or other record in permanent form, containing the information required to be kept on site in accordance with the Act and applicable Regulations;

- 2.7 **“Health and Safety Plan”** means a documented plan which addresses the hazards identified and include safe work procedures to mitigate, reduce or control the hazards identified;
- 2.8 **“Risk Assessment”** means a programme to determine any risk associated with any hazard at a construction site, in order to identify the steps needed to be taken to remove, reduce or control such hazard;
- 2.9 **“the Act”** means the Occupational Health and Safety Act No. 85 of 1993.
3. The Contractor shall, in accordance with the Act and applicable Regulations, make all the necessary appointments of competent persons in writing on a form similar to Annexure 2 of this Specification and deliver copies thereof to the Procurement Manager / SHEQ Manager / Technical Manager. Copies should also be retained on the health and safety file.
- 3.1 Subcontractors shall also make the above written appointments and the Contractor shall deliver copies thereof to the Procurement Manager / SHEQ Manager / Technical Manager.
- 3.2 In the case of a self-employed Contractor or any subcontractor who has the appropriate competencies and supervises the work himself, the appointment of a construction supervisor in terms of regulation 6.1 of the Construction Regulations, 2003 will not be necessary. The Contractor shall in such a case execute and sign a declaration, as in Annexure 3, by which he personally undertakes the duties and obligations of the "Chief Executive Officer" in terms of section 16(1) of the Act.
- 3.3 The Contractor shall, before commencing any work, obtain from the Procurement Manager / SHEQ Manager / Technical Manager an access certificate as in Annexure 4 executed and signed by him, permitting and limiting access to the designated site or place of work by the Contractor and any subcontractors under his control.
- 3.4 Procedural compliance with Act and Regulations, as above, shall also apply to any subcontractors as employers in their own right. The Contractor shall furnish the Procurement Manager / SHEQ Manager / Technical Manager with full particulars of such subcontractors and shall ensure that they comply with the Act and Regulations and safety requirements and procedures.

#### 4. **Special Permits**

Where special permits are required before work may be carried out such as for hot work, isolation permits, work permits and occupations, the Contractor shall apply to the Procurement Manager / SHEQ Manager / Technical Manager or the relevant authority for such permits to be issued. The Contractor shall strictly comply with the conditions and requirements pertaining to the issue of such permits.

#### 5. **Health and Safety Programme**

- 5.1 The Tenderer shall, with his tender, submit a Health and Safety Programme setting out the practical arrangements and procedures to be implemented by him to ensure compliance by him with the Act and Regulations and particularly in respect of: -
- (i) The provision, as far as is reasonably practical, of a working environment that is safe and without risk to the health of his employees and subcontractors in terms of section 8 of the Act;

- (ii) the execution of the contract work in such a manner as to ensure in terms of section 9 of the Act that persons other than those in the Contractor's employment, who may be directly affected by the contract work are not thereby exposed to hazards to their health and safety;
  - (iv) ensuring, as far as is reasonably practical, in terms of section 37 of the Act that no employee or subcontractor of the Contractor does or omits to do any act which would be an offence for the Contractor to do or omit to do.
- 5.2 The Contractor's Health and Safety Programme shall be based on a risk assessment in respect of the hazards to health and safety of his employees and other persons under his control that are associated with or directly affected by the Contractor's activities in performing the contract work and shall establish precautionary measures as are reasonable and practical in protecting the safety and health of such employees and persons.
- 5.3 The Contractor shall cause a risk assessment contemplated in clause 5.2 above to be performed by a competent person, appointed in writing, before commencement of any **Construction Work** and reviewed during construction. The Risk Assessments shall form part of the Health and Safety programme to be applied on the site and shall include at least the following:
- The identification of the risks and hazards that persons may be exposed to;
  - the analysis and evaluation of the hazards identified;
  - a documented Health and Safety Plan, including safe work procedures to mitigate, reduce or control the risks identified;
  - a monitoring and review plan.
- 5.4 The Health and Safety Plan shall include full particulars in respect of: -
- The safety management structure to be instituted on site or place of work and the names of the Contractor's health and safety representatives and members of safety committees where applicable;
  - the safe working methods and procedures to be implemented to ensure the work is performed in compliance with the Act and Regulations;
  - the safety equipment, devices and clothing to be made available by the Contractor to his employees;
  - the site access control measures pertaining to health and safety to be implemented;
  - The introduction of control measures for ensuring that the Safety Plan is maintained and monitored for the duration of the Contract.
- 5.5 The Health and Safety programme shall be subject to the Procurement Manager / SHEQ Manager / Technical Manager's approval and he may, in consultation with the Contractor, order that additional and/or supplementary practical arrangements and procedures be implemented and maintained by the Contractor or that different working methods or safety equipment be used or safety clothes be issued which, in the Procurement Manager / SHEQ Manager / Technical Manager's opinion, are necessary to ensure full compliance by the Contractor with his obligations as an employer in terms

of the Act and Regulations. The Procurement Manager / SHEQ Manager / Technical Manager or his deputy shall be allowed to attend meetings of the Contractor's safety committee as an observer.

- 5.6 The Contractor shall take reasonable steps to ensure that each subcontractor's Health and Safety Plan is implemented and maintained on the construction site: Provided that the steps taken shall include periodic audits at intervals mutually agreed to between the them, but at least once every month.
- 5.7 The Contractor shall stop any subcontractor from executing any construction work, which is not in accordance with the Contractor's, and/or subcontractor's Health and Safety Plan for the site or which poses a threat to the health and safety of persons.
- 5.8 The Contractor shall ensure that a copy of the Health and Safety Plan is available on site for inspection by an inspector, Procurement Manager / SHEQ Manager / Technical Manager, agent, subcontractor, employee, registered employee organization, health and safety representative or any member of the health and safety committee.
- 5.9 The Contractor shall consult with the health and safety committee or, if no health and safety committee exists, with a representative group of employees, on the development, monitoring and review of the Risk Assessment.
- 5.10 The Contractor shall ensure that all employees under his control are informed, instructed and trained by a competent person regarding any hazard and the related work procedures before any work commences, and thereafter at such times as may be determined in the Risk Assessment.
- 5.11 The Contractor shall ensure that all subcontractors are informed regarding any hazard as stipulated in the Risk Assessment before any work commences, and thereafter at such times as may be determined in the Risk Assessment.
- 5.12 The Contractor shall ensure that all visitors to a construction site undergoes health and safety induction pertaining to the hazards prevalent on the site and shall be provided with the necessary personal protective equipment.

## **6. Fall Protection Plan**

- 6.1 In the event of the risk and hazard identification, as required in terms of clause 5.3 of this Specification, revealing risks relating to working from an elevated position the contractor shall cause the designation of a competent person, responsible for the preparation of a fall protection plan;
- 6.2 The Contractor shall implement, maintain and monitor the fall protection plan for the duration of Contract. The Contractor shall also take such steps to ensure the continued adherence to the fall protection plan.
- 6.3 The fall protection plan shall include: -
  - A Risk Assessment of all work carried out from an elevated position;
  - The procedures and methods to address all the identified risks per location;
  - The evaluation of the employees' physical and psychological fitness necessary to work at elevated positions;

- The training of employees working from elevated positions; and
- The procedure addressing the inspection, testing and maintenance of all fall protection equipment.

## 7. Hazards and Potential Hazardous Situations

The Contractor and the Procurement Manager / SHEQ Manager / Technical Manager shall immediately notify one another of any hazardous or potentially hazardous situations which may arise during performance of the Contract by the Contractor or any subcontractor and, in particular, of such hazards as may be caused by the design, execution and/or location and any other aspect pertaining to the contract work.

## 8. Health and Safety File

- 8.1 The Contractor shall ensure that a health and safety file is opened and kept on site and shall include all documentation required as per the Act and applicable regulations, and made available to an inspector, the Procurement Manager / SHEQ Manager / Technical Manager, or subcontractor upon request.
- 8.2 The Contractor shall ensure that a copy of the both his Health and Safety Plan as well as any subcontractor's Health and Safety Plan is available on request to an employee, inspector, contractor or the Procurement Manager / SHEQ Manager / Technical Manager.
- 8.3 The Contractor shall hand over a consolidated health and safety file to the Procurement Manager / SHEQ Manager / Technical Manager upon completion of the **Works** and shall in addition to documentation mentioned in the Act and applicable Regulations include a record of all drawings, designs, materials used and other similar information concerning the completed structure.

### HSE philosophy

Inherent safety and protection of the environment is a prerequisite from the beginning of the design process. The HSE philosophy must be included in the design premise document, and should include considerations on waste reduction, minimisation of fugitive emissions, ground water pollution prevention, minimisation of manning levels for hazardous processes, hazardous materials handling, early detection systems and specific measures to reduce risks to ALARP levels.

### Hazard identification study

A systematic evaluation of all hazards shall be performed in the hazard study. The hazard study is the basis for the area classification drawings and may alter the location of for example buildings, process units on the plot plan or may lead to additional preventive measures (firewalls, other material types etc) being required.
