- Quotation will be awarded as whole (service required is for the supply of disposable containers for medical waste and removal of medical waste bins from the two Centres and the Pharmacy at Zonderwater Management Area for the period of 8 months.
- The quoted boxes, containers and other resources should be once off delivery at Centre A, Centre B and Pharmacy.
- Collection of medical waste: once a week (on Thursdays between 07H30 and 14H00) and when there is a need.
- The company to provide training on sealing off and handling of medical waste. To be done on site at no cost.
- The company must provide Disposal certificate indicating place of disposal, in all the Correctional Centres when sending-in the invoice for payment.
- Accreditation certificate for removal and treating the medical waste according to National Environmental Management Waste (NEMA) Act 59 of 2008 and its associated Regulations and Norms and Standards.
- The service and containers to comply with all aspects as prescribed in the National Environmental Management Act 107 Of 1998; National Environmental Management Waste (NEMA) Act 59 of 2008 and its associated Regulations and Norms and Standards; Occupational Health and Safety Act 85 of 1998; Environmental Conservation Act, 1989 (Act No. 73 Of 1989) as well as the Gauteng Health Care Waste Management Regulations 2004.
- The Bidder **must** be registered in Gauteng waste information system (GWIS) as transporter of hazardous waste to be disposed of/treated at land fill site/waste handling facility authorised to dispose such waste.

“ALL APPLICABLE TAXES” includes Value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies.
