1. PURPOSE

The purpose of this bid is to appoint a service provider to provide a timed online auction bidding platform and related services for the sale of wildlife to SANParks for two (02) years.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

In terms of Section 55(2) (b) of the National Environmental Management: Protected Areas Act 57 of 2003, South African National Parks, in managing national parks, is mandated to sell, exchange, or donate any animal, plant or other organism occurring in a park, or purchase, exchange or otherwise acquire any indigenous species which it may consider desirable to reintroduce in a specific park.

3. SCOPE OF WORK

The prospective bidder is expected to provide a timed online auction bidding platform and related services for the sale of wildlife for two (2) years as detailed in this scope of work.

The project will consist of the following elements:

Auction Bidding Platform

- o Presentation of a Bidding Application (Web & App based).
- o Hosting of the wildlife sale via a Bidding App.
- o Comply with standard auction rules
- o Registration of buyers
- o Personalized (Corporate Branding) option for cataloguing
- o Option for timed, livestream, virtual-live or physical-live auction bidding
- o Real-time notifications
- o Real-time bid updates
- o Lots closing in staggered intervals option
- o Bidding App browser function
- o Standard conditions of sale

Auction Bidding App Marketing Strategy (Direct and Digital Marketing)

- o To create a marketing strategy / media campaign in collaboration with the SANParks.
- o Marketing campaign via WhatsApp, Facebook and Instagram and any other social media platforms to promote the auction.
- o Marketing content as well as photography to be provided and designed by the service provider.
- o Service provider to have an SMS database of a minimum of 6000 cell phone contacts of clients in the wildlife industry.
- o The service provider to have an Email database of a minimum of 6000 email addresses of clients in the wildlife industry.
- o Pre-recorded promotional video display
- o In-line or audio live streaming

Financial Management

- o Must have an inhouse finance team
- o Invoicing of all buyers
- o Service provider must have a dedicated trust account to receive payments from buyers.
- o After sale reports and services
- o Auctioneer must demonstrate financial control over fund management.

Auction Governance

o The service provider must have the capacity to manage complex aspects of an auction bidding platform to ensure compliance to protect all involved parties (Buyer, seller) and have the following minimum measures in place.

- Risk management
- Legal
- Auditing
- Compliance with Consumer Protection Act
- Assist with facilitating client permit applications

Upon appointment, the recommended service provider is expected, in collaboration with SANParks, to agree to the best timeframe to host the auction via an auction App bidding platform. SANParks reserves the right to cancel the Purchase Order if the recommended service provider fails to deliver within an agreed period.

10. FINANCIAL PAYMENT

Payment to the service provider by SANParks in respect of services

Payment will be made in accordance with the PFMA (within 30 days) upon receipt of an invoice for services rendered as per the scope of work.

Payment to SANParks by the service provider in respect of sales

The service provider undertakes.

1. To make a 20% payment of the turnover to SANParks, 5 days after the closure of the auction.
2. To make payments to SANParks promptly, but in no case, later than seven (7) days after receipt of an invoice and delivery notes from SANParks, confirming delivery to a buyer.
3. Payment of commission will only be confirmed upon receipt of animal delivery note and a valid invoice.

SANParks Responsibility.

- SANParks will capture and load the animals at source.
- SANParks will invoice the service provider based on delivery notes.
- SANParks will invoice the service provider for additional animals delivered.
- SANParks will invoice the service provider for the payable commission.
- SANParks will only capture, and release animals based on confirmation of payment and valid authorization permits.

11. FINAL AWARD

SANParks recommends the bidder who has quoted on all the items as required in terms of the RFQ for the contract award subject to the bidder having supplied the relevant administrative documentation and complied in all aspects with the terms and conditions and requirements of the RFQ.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
