1. INVITATION AND BACKGROUND

1.1 Invitation to Quote

Johannesburg Water SOC Ltd (hereinafter referred to as "Johannesburg Water" or "JW") hereby invites suitably qualified, experienced and reputable service providers to submit quotations for the appointment of a professional advisory firm to provide strategic ICT Advisory Services to Johannesburg Water for a period of twelve (12) months.

The appointed Advisor will act as a senior, executive-level partner to the Office of the Chief Financial Officer (CFO), the Executive Committee and the Board sub-committees of Johannesburg Water, providing advisory services across the ICT value chain — including enterprise data transformation, ICT governance, ITSM, project and portfolio governance, and ICT performance optimisation.

This Request for Quotation (RFQ) is issued in accordance with the Public Finance Management Act (PFMA), the Municipal Finance Management Act, No. 56 of 2003 (MFMA), the Preferential Procurement Policy Framework Act, No. 5 of 2000 (PPPFA) as amended, the Preferential Procurement Regulations, 2022, and Johannesburg Water's approved Supply Chain Management Policy.

About Johannesburg Water

Johannesburg Water SOC Ltd is a municipal entity incorporated on 21 November 2000 and is wholly owned by the City of Johannesburg Metropolitan Municipality, its sole shareholder. The Entity provides water and sanitation services to an area stretching from Orange Farm in the south to Midrand in the north, Roodepoort in the west, and Alexandra in the east.

Johannesburg Water supplies approximately 1.6 billion litres of potable water per day, procured in bulk from Rand Water, and treats approximately 909 megalitres of wastewater per day at six wastewater treatment works, including two biogas-to-energy plants. The Entity serves over five million residents and remains one of the largest water and sanitation utilities on the African continent.

1.3 Strategic Context and Need

Johannesburg Water is embarking on a multi-year digital, data and ICT modernisation journey aimed at improving operational performance, non-revenue water reduction, customer experience, cyber resilience, and evidence-based decision-making. ICT, data and operational technology (OT) are recognised as strategic enterprise enablers of the Entity's Turnaround Strategy, its Asset Management Strategy, and its obligations as a key service delivery partner of the City of Johannesburg.

To accelerate this transformation, Johannesburg Water requires the services of a seasoned, executive-level Advisor, appointed to and reporting to the Office of the Chief Financial Officer, to architect and govern enterprise-wide ICT frameworks — integrating IT service management, project and portfolio governance, and performance management — to ensure regulatory compliance, strategic alignment, and value-driven technology investments. The Advisor shall provide independent, board-grade counsel to the CFO and oversee the maturity uplift of the ICT function over the contract term.

2. SCOPE OF ADVISORY SERVICES

The appointed Advisor shall, working under the direction of and reporting to the Office of the Chief Financial Officer, provide advisory services across the following critical performance areas. The list below is indicative and not exhaustive:

2.1 Enterprise Data Transformation Strategy

- Conduct a current-state assessment of Johannesburg Water's data landscape and define the future-state Enterprise Data Architecture.
- Develop and drive a multi-year Data Transformation Strategy, roadmap, business case and benefits realisation plan.
- Establish an enterprise Data Governance Framework aligned with DAMA-DMBOK principles, defining ownership, stewardship and decision rights.
- Define standards for data quality, master and reference data, metadata, classification, retention and disposal.
- Advise on the modernisation of data platforms (warehouse, lake, Lakehouse), IT/OT integration (SCADA, telemetry, smart metering), and the responsible use of artificial intelligence and machine learning.
- Ensure data practices are fully aligned with the Protection of Personal Information Act (POPIA), the Promotion of Access to Information Act (PAIA), King IV and applicable provisions of the MFMA and PFMA.

2.2 ICT Governance Framework, Policies and Standards

- Develop and maintain the enterprise ICT governance framework, policies and standards aligned with COBIT 2019, ISO/IEC 38500 and ITIL 4.
- Ensure ICT strategy alignment with business objectives and digital transformation initiatives.
- Report to the Office of the CFO, executive leadership and Board sub-committees on ICT governance matters.

2.3 ITSM, Performance Optimisation and Project Governance

- Govern ITIL 4 service management practices and define SLAs and OLAs across ICT service delivery.
- Oversee project portfolio governance, including prioritisation, funding and stage-gate reviews.
- Integrate project governance (PMBOK/PRINCE2) into the systems development lifecycle and agile delivery frameworks.

2.4 ICT Performance Monitoring, Evaluation and Optimisation

- Develop ICT performance metrics, KPIs, dashboards and scorecards aligned with strategic and operational goals.
- Benchmark ICT capabilities against industry standards and advise on ICT investment prioritisation to maximise business value.

2.5 Capacity Building, Mentorship and Skills Transfer
