NOTICE IN TERMS OF SECTION 33 OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, NO. 56 OF 2003

NOTICE IS HEREBY GIVEN in terms of Section 33 of the Local Government: Municipal Finance Management Act, No. 56 of 2003 that the Johannesburg Metropolitan Municipality ("the Municipality") intends entering into an agreement which will impose financial obligations on the Municipality for a period longer than the three years covered in the annual budget for the financial year 2022/2023. **The contract relates to appointment of a service provider/s for the provision of non-specialised vehicles on a Full Maintenance Lease (FML) and fleet support services for both FML and managed maintenance on existing fleet for a period of five (5) years for all core departments and Municipal Owned Entities (MOEs) for a period of 5 (five) years.**

NOTICE IS FURTHER GIVEN in accordance with Section 21A and Section 21 of the Local Government: Municipal Systems Act, No. 32 of 2000 that -
