SCOPE OF WORK:

1. BACKGROUND OF THE RAF

The Road Accident Fund (RAF) is a schedule 3A public entity established in terms of the Road Accident Fund Act, 1996 (Act No. 56 of 1996), as amended. Its mandate is the provision of compulsory social insurance cover to all users of South African roads, to rehabilitate and compensate persons injured as a result of the negligent driving of motor vehicles in a timely and caring manner, and to actively promote the safe use of our roads.

The customer base of the RAF comprises not only the South African public, but all foreigners within the borders of the country. The RAF head office is in Centurion and RAF intends to establish Customer Experience Centres (CEC) in each province in the country.

2. SPECIAL INSTRUCTION TO BIDDERS AND RFI CONDITIONS

- 2.1 The service provider must be an eligible, registered Service Provider in terms of the applicable laws of the Country and included in the National Treasury Central Supplier Database.
- 2.2 It is expected of bidders to have their Tax matters in order when the proposals are submitted.
- 2.3 Companies or Director that are included on the National Treasury register for Restricted Suppliers and/ or Tender Defaulters will be automatically disqualified from the process.
- 2.4 This RFI is only for information purposes
- 2.5 The costs of preparing the submission shall not be reimbursed.
- 2.6 The bidder to provide a comprehensive proposed solution and how it addresses all the requirements
- 2.7 Also include a proposed Implementation Plan: This should include how the project will be phased and the timing thereof.
- 2.8 The bidder must provide total cost of the proposed system

3. BACKGROUND OF THE BID

The RAF has several IT systems deployed across different hosting environments including on-premises and on-cloud platforms. These IT systems integrate to share information for business purposes. Currently, all Master and Reference data is set up in a point-to-point / system-to-system architecture wherein Master and Reference Data (data that must be shared and changes infrequently) is maintained (captured, updated, and deleted) per system.

Current challenges

Having multiple sources of Master and Reference Data generated captured, updated, and deleted per system causes critical problems relating to data quality and integrity, especially in medium to large organizations. These problems are normally associated with high costs (duplicate claims, incorrect payments), damage to company reputation and other damaging factors. Master and Reference Data changes over time, and for that reason it may get out of sync from system to system and thus become fragmented, incomplete, inaccurate, and inconsistent.

3.1. REQUIREMENTS

The RAF requires the services of suitably qualified service provider to provide information that will assist in the proper procurement of Master and Reference Data Management Tool and other services including:

- Installation, maintenance, and support of Master Data and Reference Data management tool and the developed solution/s.
- Prerequisites / preplanning by the RAF to enable the service provider to analyze the current RAF Master and Reference Data capability.
- Knowledge Transfer and Training of RAF staff throughout the implementation with regards to the developed solution/s.
- Provide project plan and duration of how the solution will be developed and rolled-out.
- Provide guidance with regards to hosting of Master Data and Reference Data management tool in the cloud within South African borders.

3.1.1. The proposal must demonstrate:

- Data Integration How Master Data and Reference Data tool communicates with Enterprise Integration Platform and using protocols such as: API, ODBC, JDBC, RFC, REST, SOAP, sFTP, SMTP, XML, JSON, CSV.
- Data Quality Management How the Data and Reference Data tool identifies, collects, transforms, and repairs data for the purpose of cleansing of data.
- Data Access and Distribution Provide guidance on the roles and access needed to use the tool.
- Metadata Management How the bidder will create a metadata catalogue capability.
- **Data Governance** How they will implement security and governance controls, such as role-based access controls and activity audit logs.
- Master Data Creation and Maintenance Demonstrate that the selected tool must be flexible and agile to evolve and adapt to new business needs.

- **Data Synchronization** The selected tool must be able to automate the identification, matching, and merging of data across the systems.
- **Hierarchy Management** How accurate reporting and analysis will be implemented.
- Data Lifecycle Management Demonstrate the complete lifecycle of master data, from creation to archiving or deletion, in compliance with retention policies and regulations.
- Data Security and Privacy How security measures to control access to sensitive
 master data will be enforced, to help in ensuring that only authorized individuals can view
 and modify it.
- **Data Modelling and Standardization** Define data models and standards to help ensure uniformity in data structures, formats, and definitions.
