Azarenka, Andreescu advance to second round at Guadalajara

Twice major winner Victoria Azarenka downed Russian Elina Avanesyan 6-4 6-2 and former US Open champion Bianca Andreescu cruised past Swiss Jil Teichmann 6-2 6-4 in the first round of the Guadalajara Open.

Six of the world's top 10 are expected to play in the hard-court tournament, the final WTA 1000-level event this season before the WTA Finals, with Polish world number one and US Open winner Iga Swiatek absent after winning in San Diego on Sunday.

Azarenka, who reached the last 16 in New York but lost in her Ostrava opener earlier this month, dropped only three first-set points in the first set and broke in the seventh game.

The Belarusian's serve deteriorated in a choppy second set but her 20-year-old opponent could not derail the experienced Azarenka, who set up a second-round meeting with Spanish top seed

Paula Badosa in a repeat of the Indian Wells final last year.

Canadian Andreescu had no problem overcoming Teichmann, winning the first three games of the first set and cruising through the second as the Swiss served three double faults.

Andreescu's win sets up a first career meeting with Petra Kvitová after the Czech put on a serving masterclass and crushed six aces to overpower Bernarda Pera 6-3 7-5.

Russian Liudmila Samsonova, who won in Cleveland and Tokyo this year but lost her first-round match in San Diego, beat Estonian Kaia Kanepi 6-1 7-5 and China's Zhu Lin defeated Frenchwoman Alize Cornet 3-6 6-3 6-4.

The biggest upset of the day belonged to 20-year-old Colombian Camila Osorio, who broke 15th seed, Ekaterina Alexandrova, nine times en route to a 6-4 7-6(8) victory.

American Sloane Stephens, Bel-

gian Elise Mertens, Ukrainian Marta Kostyuk and Canadian Rebecca Marino all advanced to the second round after straight sets wins.

• Meanwhile, Holger Rune continued his strong indoor season with a fast start at the Stockholm Open on Monday.

Making his debut at the ATP 250 in Sweden, the #NextGenATP Dane scored a 7-5, 6-2 win against Thiago Monteiro.

The seventh seed did not face a break point in the match and won five of six games to take command from 4-5 in the opening set.

He secured his third break late in the second set before serving out the match to love, finishing with a 86 per cent (31/35) win rate on the first serve.

Fourth in the Pepperstone ATP Live Race To Milan, Rune could pass Lorenzo Musetti for third place with a deep run in Stockholm — though the Italian is competing in Naples this week.

Both men have secured qualification for the Intesa Sanpaolo Next Gen ATP Finals.

After reaching the Metz quarter-finals and the Sofia final, Rune will seek a third straight indoor quarterfinal when he takes on Cristian Garin in the second round.

Garin also advanced on Monday with a 6-2, 6-4 win against Aussie Jason Kubler.

Aslan Karatsev set up a second-round showdown with second seed Cameron Norrie by easing past Lukas Rosol 6-3, 6-2 to close the day's play on Stockholm's centre court.

In the lone three-setter of the day, Maxime Cressy edged Ilya Ivashka 4-6, 7-6(5), 6-4.

The American will next face top seed Stefanos Tsitsipas in what will be the Greek's opening match. — Reuters, ATP Tour
