TERMS OF REFERENCE

1. Purpose

The Buffalo City Metropolitan Development Agency (BCMDA) would like to invite service providers who are experienced and competent in developing and implementing **consumer location intelligence systems** as well as platforms for marketing and promoting tourism and recreational facilities.

2. Background

The Buffalo City Metropolitan Development Agency (BCMDA) is a municipal entity wholly owned by the Buffalo City Metropolitan Municipality and established in terms of S76 of the Municipal Systems Act, 32 of 2000, as amended. The primary mandate of BCMDA is to attract investors into Buffalo City and increase economic growth through tourism, economic and social development as well as property management and commercialisation.

The BCMDA is currently developing its two flagship projects, the Court Crescent, and Waterworld Recreational Parks. Both facilities are designed to host events and other activities that are expected to attract multitudes of event goers. As part of marketing the facilities, the BCMDA intends to develop a consumer location intelligence system in order to capture potential consumers through pop-up adverts and other marketing campaigns.

3. Terms of Reference

The BCMDA is looking for a location intelligence platform that focuses on using location to both **build audiences** as well as deliver marketing campaigns within specific geo fences(space) from 1km down to 10-meter radius. The application must be able target users who have been in a specific location up to 90 days. The system must be able to measure footfall into specific designated spaces.

The successful service provider is expected to undertake the following functions:

Task 1: Develop and implement a digital platform to capture audiences and geo-fence specific locations from radius of 1km down to 10 metres from East London/King Phalo Airport to other additional 10 designated areas that will be identified by BCMDA.

Task 2: Develop a platform with 200 000 impressions (pop-up adverts). The costs should include design and layout of the impressions.

Task 3: Design and deliver pop up adverts and notices on mobile devices, targeting specific audience using location intelligence and deliver marketing campaigns.

NB: The platform to have a dashboard measure CTR (Click Through Rate).

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process.
