## CONDITIONS AND INSTRUCTION TO THE BIDDER

- a) The Bid forms should not be retyped or redrafted, but photocopies may be prepared and used.
- b) Only documents completed in black ink will be accepted. (Black ink should be used when completing Bid documents).
- c) Bidders should check the numbers of the pages to satisfy themselves that none is missing or duplicated. SANParks will accept NO liability in regard to anything arising from the fact that pages are missing or duplicated.
- d) Counter Conditions: SANParks draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.
- e) Response preparation costs: SANParks is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.
- f) Cancellation prior to awarding: SANParks reserves the right to withdraw and cancel the Bid Invitation prior to making an award. The cancellation grounds include insufficient funds, where the award price is outside of the objective determined fair market-related price range or any process impropriety.
- g) Collusion, Fraud and corruption: Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.
- h) Fronting: SANParks, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct, or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should SANParks establish any of the fronting indicators as contained in the Department of Trade and Industry's "Guidelines on Complex Structures and Transactions and Fronting" during such inquiry/investigation, the onus is on the bidder to prove that fronting does not exist? ## **SPECIAL CONDITIONS OF THE BID**

- The service provider must have the necessary skill, knowledge and expertise to provide the required services.
- The service provider must install all related infrastructure equipment in all affected areas within the first six-twelve months of this bid.
- The service provider must provide SANParks with a hard copy, as well as soft copy of the fire risk assessment report. The report must, as a minimum include the requirements of Fire Safety Standards as stipulated in the Occupational Health and Safety Act (Act 85 of 1993) and must be provided to SANParks on a Quarterly basis.
- SANParks is not obligated to appoint one service provider for all functions required in this tender.
- Due diligence review may be conducted before the awarding of the bid.
- The service provider may be required to provide any additional services that may be required as and when a need arises but not limited to the following:
  - Performance or supervision of on-site assembly and/or commissioning of the supplied goods;
  - Furnishing of tools required for assembly and/or maintenance of the supplied goods;
  - Furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
  - Performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
  - Training of the purchaser's personnel, at the supplier's plant and/or on-site, conducted in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.
- All staff will be subject to integrity testing as and when required.
- The service provider collectively with SANParks representative must prior servicing or replacing any fire protection equipment, inspect the condition and the quantity thereof.
- On completion of each service the service provider must provide a register of the serviced equipment and certification of service.
- Job-cards must be signed by the responsible SANParks official at the end of each service.

## LEGISLATIVE AND REGULATORY FRAMEWORK

SANParks seeks to appoint a service provider to provide structural fire equipment; and Risk Assessment for Kruger National Park for the period of five (5) years.

The building and infrastructure of Kruger National Park was constructed prior to the requirements of National Building Regulations: Fire Protection. The required fire system includes smoke detectors, cabling, fire sprinkler, fire extinguishers, fire hoses, fire hydrants, automated alarms system, fire panels, frosting and building management system.

Due to regular reviews of applicable fire regulations and standards, the fire detection and emergency evacuation system at SANParks (Kruger National Park) do not comply with regulations as amended. SANParks seeks to appoint a Fire Specialist/Consulting Engineer to lead the upgrade of the fire management system and possible integration of the fire detection system with the evacuation system.

## **INTRODUCTION TO SANPARKS**

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). ## **SPECIFICATIONS/SCOPE OF WORK**

### **1. FIRE RISK ASSESSMENT**

- Conduct a survey and prepare a Fire Risk Assessment and provision and servicing of firefighting equipment for the entire Kruger National Park.
- Conduct a survey and prepare a Fire Risk Assessment report with recommendations to ensure that the entity complies with the Fire Safety Standards as stipulated in the Occupational Health and Safety Act 85 of 1993, Section 8.
- Provide a detailed approach to be followed which should comprehensively identify fire hazards, and evaluate the adequacy of prevention systems.

- Identify all possible sources of ignition in the workplace as well as the levels of combustible materials in the workplace.
- Evaluate and review facilities, plant, equipment, and processes to identify fire hazards in the workplace.
- Assessing the risk that employees, customers, or other members of the public that may have access to the premises.
- Evaluate the adequacy and the appropriateness of the types and nature of all the fire equipment.
- Evaluate the adequacy and the completeness of the fire systems including prevention/protection and alarm systems.
- Evaluate and review facilities, plant, equipment, and processes to identify any flammable liquids and gases.
- Provide mitigation measures and actions thereof.
- Provide timelines for action.

## **2. STRUCTURAL FIRE EQUIPMENT**

- Provide standard signs and general requirements signage in line with SANS 10400 (National Building Regulations) Part T: Fire Protection, Relevant Municipal By-laws and SANS 1186-1:2003 Part 1 symbolic safety signs to follow in case of an emergency for assembling point and fire Marshall arrows, firefighting equipment signs where applicable.
- Provision, installation, maintenance, replacement, and repair of firefighting system as per SANS 10254 including on a yearly basis, for instance but not limited to:-
  - When the firefighting equipment is missing a service provider should be able to replace
  - When the firefighting equipment does not have enough pressure the service provider should maintain it.
  - When the firefighting equipment is damaged, the service provider should repair or replace dependable on the nature of the damages.
  - Fire hydrants to be assessed and tested for.
- The designed system must comply with the following SANS standards:
  - SANS 10139
  - SANS 306-4

- SANS 10287
- SANS 14520-1

## 2.1 Equipment Description

### 2.1.1 Fire Hose Reels

- Mounting brackets shall be checked to ensure that they hold the hose reel in position to allow designed use of equipment.
- Components of the hose reel shall be checked whether they are functioning as prescribed by the manufacturer.
- Water control fittings of the hose reel shall be checked whether they are functioning as prescribed by the manufacturer.
- The fire hose shall be checked whether.
  - it is not more than 30 m or less than 28 m in length, and
  - It is free from joints.
- All water seals shall be checked for leakage.
- At the end of the service, service labels shall be completed and fitted
- Service labels:

When all the relevant inspection and service procedures have been completed, record, indelibly and on an acceptable, waterproof, adhesive labels that is firmly fixed to the fire hose reel, the following information:

- The name, physical address and contact number of the reconditioning organization
  - The date of service and the next service due date.
  - Pressure at the time of service
  - The handle shall be sealed in a manner that prevents use without breaking using an acceptable safety
- Positioning of service labels

The fire hose reels must have two service labels applied on the following positions:

- One service label on the outside of the front hose reel disc; and
- One service label in a position that is visible once the fire hose reel is fully unwound.

## **2.1.2 FIRE EXTINGUISHERS**

If fixed extinguishers have to be removed from site, the necessary arrangements shall be made with the responsible SANParks official to ensure satisfactory protection with a replacement.

### **2.1.2.1 Filling Mediums:**

- Only powder that complies with the requirements of SABS 1522 must be used for refilling fire extinguishers.
- If, during servicing, powder is removed for the effective inspection and control of a cylinder, the powder may be re-used, subject to the following:
  - The powder must be sieved and if it is determined during sieving, that the powder is free from lumps, the powder may be re-used; if not, must be discarded. Powder so qualified for re-use must be identified with the cylinder from which it was removed.
  - The powder must be sieved and if it is determined, during sieving, that the powder is free from lumps, the powder may be re-used; if not, it shall be discarded. Powder so qualified for re-use shall be identified with the cylinder from which it was removed.
  - CO2 extinguishers must be charged with CO2 that complies with the requirements of SABS 1567.
  - Foam extinguishers must be charged only with the type of foam marked on the extinguisher label.
  - CO2 and foam extinguishers must not be topped up but shall be emptied and fully recharged.

### **2.1.2.2 External Checks:**

- Thoroughly clean the container and examine the exterior for corrosion and physical damage and, if any damage to the seams or joints is observed, remove the extinguisher from service and submit it for a major service.
- If there are minor dents in the container, remote from any seam or joint, allow the extinguisher to remain in service.
- If the registered person does not consider the severity and extent of corrosion to be serious, clean, repaint and re-label the container in a way that ensures compliance with the requirements of the original manufacturer.
- Check all component parts for corrosion and physical damage (i.e., breakage, deformation, cracks, discoloration of plastics parts, etc.). If necessary, replace parts with the correct components recommended and supplied by the fire extinguisher

manufacturer. If such components are not available, use parts that comply with the requirements of the original manufacturer. If this is not possible, the extinguisher shall be condemned.

#### **2.1.2.3 Fire Extinguisher Hose**

- Examine it for wear and kinking.
- If the fire hose is not in good condition, replace it with a fire hose of acceptable quality and design as per the specifications.

#### **2.1.2.4 Mounting Brackets:**

- Examine the mounting brackets for physical damage and firm anchorage
- Ensure all fire extinguisher are place over 3cm.

#### **2.1.2.5 Mass of extinguisher**

- Determine the full mass of the extinguisher and, if it is found to vary by more than 5 % from the marked full mass, present the extinguisher for a major sservice.
- If no mass is marked on the extinguisher, determine the actual mass, and record it on the new service label attached to the extinguisher.

#### **2.1.2.6 Pressure indicating devise:**

When all the relevant inspection and service procedures have been completed, record, indelibly and on an acceptable, waterproof, adhesive label that is firmly fixed to the fire hose reel, the following information:

- The name, physical address and contact number of the reconditioning organization
- The date of service; and
- The next service due date.
- Pressure at time of service
- The handle shall be sealed in a manner that prevents use without breaking using an acceptable safety seal.

### **2.1.3 FIRE HYDRANTS**

Testing of fire hydrants and provision of testing label after testing according to SANS 1475 -2. Each piece of equipment to also follow the service standards as required by the Original Equipment Manufacturer (OEM). Where OEM standards differ from those required by this document the more stringent requirement shall apply. The Contractor will be fully responsible for obtaining (and keeping up to date with) said requirements.

### **2.1.3.1 Hydrant System:**

- Check for leaks in outlets of hydrant and remedy – repair or replace gaskets, packing or parts as necessary.
- Check for cracks in hydrant barrel and remedy (repairs or replace as necessary)
- Check chains, make sure they allow the nozzle cap to turn freely.
- Check all caps, make sure they all can be removed.
- Check paint, remove all loose paint and repaint if necessary.
- Check and ensure that nozzle/pumper port/threads are working and repair and replace as necessary.
- Check operating nut and ensure it is in good working condition repair parts and replace as necessary.
- Check and repair leaking valves, flanges, nozzles/pumper, seals and operating nut.
- Open hydrant fully and check ease of operation and all other inspection covered under SANS 1475.
