STATEMENT OF WORK – DRYDOCK CAPSTANS OVERHAUL AND HYDRAULIC DRIVE RETROFIT FOR ARMSCOR DOCKYARD, SIMONS TOWN.

1. INTRODUCTION

Armcor Dockyard provides maintenance, docking, and undocking services for the South African Navy's vessels and offers similar services for commercial vessels. The Dry Dock and Syncrolift are the primary facilities used for these operations. A key component in this process is the capstan, which provides the necessary pulling force, secure grip, and release mechanisms for vessels during docking and undocking.

There are currently nine (9) capstans installed in the Dry Dock area. The hydraulic pumps, hydraulic motors, and some associated hydraulic drive components used on these capstans have become obsolete and require complete replacement.

A qualified service provider is required to supply capstan number 12 with a new replacement hydraulic pump and motor, hydraulic valves and pipes, then perform the installations and commissioning of capstan 12 to restore it to a pulling capacity of 20 tons at 8 m/min under full load and 27 m/min under no load.

2. REQUIREMENTS

The requirement is for the service provider to supply and install a completely new hydraulic drive system, replacing all critical hydraulic components with modern, high-efficiency and quality units from OEMs. The service provider will be responsible for the following:




