

NOTICE T22/25/26 REPLACEMENT OF CLARIFIER BRIDGE AT MALMESBURY WWTW

Swartland Municipality invites tenders for the replacement of a clarifier at Malmesbury Wastewater Treatment Works (WWTW). The project entails the installation new syphon suction rotating half bridge and supports complete with centre bearings, syphon pipes, sludge scrapers, sludge collection box, scum draw-off, end carriage, drive, access ladders and associated equipment for Clarifier No.1. The work will also include minor refurbishments of Clarifier No.2.

Tenderers must be registered with the CIDB in a **ME** Class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with Regulation 25(1B) or 25(7A) of the Construction Industry Development Regulations, 2004. The estimate for the contract lies within the range R 1 000 000 to R 3 000 000.

The physical address for collection of tender documents is the Offices of the Director: Civil Engineering Services, Swartland Municipality, Piet Retief Street, Malmesbury. Documents may be collected during working hours after **09:00 from Monday**, **29 September 2025.** A non-refundable tender fee of **R 510-00**, payable in cash to Swartland Municipality is required on collection of the tender documents. A **Compulsory** Clarification Meeting with representatives of the Employer will take place at the Malmesbury Wastewater Treatment Works, Industrie SGL Street in Malmesbury on **Tuesday**, **7 October 2025**, at **10:00** (**Registration closes at 10:05**).

Bids will be evaluated in accordance with the Council's Preferential Procurement Policy and the attached specifications. The 80/20-preference point system will be used for the evaluation of the contract. The Preferential Procurement Policy will be available for perusal during normal office hours at the municipal offices. Preference points will not be allocated if Annexure MBD 6.1, included in the tender documents, is not completed. Preference points MUST also be claimed in paragraph 6.1. Bidders are required to submit original and valid B-BBEE Status Level Verification Certificates or certified copies thereof together with their bids, to substantiate their B-BBEE rating claims. The Municipality reserves the right to request proof of empowerment, and to ensure that the creation of suitably remunerated employment opportunities for historically disadvantaged individuals is indeed realised. Bidders are also required to submit Proof of Locality in order to claim points for locality.

Duly completed tenders in a sealed envelope marked "TENDER T22.25.26: REPLACEMENT OF CLARIFIER BRIDGE AT MALMESBURY WWTW", together with the name and address of the Tenderer must be deposited in the tender box at the Municipal Offices, 1 Kerk Street, Malmesbury before 12:00 on Monday, 20 October 2025 upon which the tenders will be made public.

Late tenders will not be accepted and the Municipality will not be compelled to accept the lowest or any tender. The Municipality reserves the right to omit any part of the tender.
