1. Description of the Goods

The scope of goods to be provided by the supplier is for the Provision and Commissioning of Meeting Equipment and Conferencing Facilities in Boardrooms and Meeting Rooms at Various Transnet Pipelines Sites. The details for the goods to be provided are as stipulated in clause 2 below.

2. Scope of Goods

2.1 Deliverables

The supplier shall:

- The service provider must propose an enterprise grade solution.
- The successful bidder will supply, deliver to sites, and install and configure the solution.
- Handover must be done for the end users and first line support staff. A signed register must be handed over.
- The equipment must be installed adhering to Transnet safety standards and requirements.
- Handover documents should include configuration documents, warranty, licensing, etc.
- Existing equipment or facilities in the boardroom will need to be decommissioned and left in the site storeroom. These asset details must be recorded in a register that will be provided by TPL ICT and must be included in the handover documents.
