### 2.3. Criteria for breaking deadlock in scoring

(1) If two or more tenderers score an equal total number of points, the contract must be awarded to the tenderer that scored the highest points for specific goals.

( 2 ) If two or more tenderers score equal total points in all respects, the award must be decided by the drawing of lots.

## **2.5.Exemption**

The Minister may, on request, exempt an organ of state from any or all the provisions of this Act if-

- (a) It is in the interest of national security
- (b) The likely tenderers are international suppliers; or
- (c) It is in the public interest

## **2.6. AWARD OF CONTRACTS TO TENDERERS NOT SCORING HIGHEST POINTS**

<p><b>Supply and delivery of skip bin x 20</b></p> <ul style="list-style-type: none"><li>- The bins are to meet the dimensional and material requirements of the ISWM standards.</li><li>- The base bin i.e. 6 m<sup>3</sup>, is to be built from 4.5mm mild steel plate. All extensions are made from 3mm mild steel plate. The basic structure of the bin is detailed below. The height the bin should be 1240mm, 3600mm width on top and 1840 at the bottom.</li><li>- All corners have one edge of the joint folded to mate with the other plate. The folded edge is positioned to provide the strength where required. The bottom of the sides folds under to support the floor. The front and rear end folds prevent the sides from opening.</li><li>- The top edge of side plates is folded to form a pressed channel edge.
