SCOPE OF WORK

1. Background

The primary function of uMngeni-uThukela Water (UW) is to provide bulk potable water, bulk sanitation, and related solutions to local municipalities in its area of operation. Water treatment residues (WTRs) and waste water sludge is the major waste stream that is produced during the operation of these facilities. According to Waste Classification and Management Regulation (R534), all waste generators must classify its waste according to SANS 10234. Waste classification needs to be conducted in terms of the South African National Standard: Globally Harmonized System of Classification and Labelling of Chemicals (GHS) SANS 10234:2008. These regulations are promulgated in terms of the National Environmental Management: Waste Act, 2008 (Act 59 of 2008) with associated Norms and Standards for the assessment of waste for landfill disposal (GN R. 635 of 2013).

2. Description of goods/ services required

This project will ensure the appointment of a Professional Service Providers to assess and classify waste water sludge for three (3) wastewater treatment works and develop a sludge classification report based on National Environmental Management: Waste Act, 2008 (Act 59 of 2008) with associated Norms and Standards for the classification and assessment of waste for landfill disposal (GN R. 634 and 635 of 2013). Additionally, the PSP to undertake the classification in accordance with the guidelines of sludge disposal as per DWS Guidelines for the utilization and disposal of wastewater sludge (Volumes 1 – 5).

3. Deliverables/Key Outcomes.
