BID INVITATION

The Sundays River Valley Municipality invites tenders for the Refurbishment of Enon & Bersheba waterborne sanitation

Tenderers should have a CIDB contractor grading designation of **6CE** or **Higher**.

The **80/20** preference point system will be applicable with **80 points** allocated to Price and **20 points** towards B-BBEE Status Level of Contribution for projects under **R50m**. Tenders will be evaluated based on the following two stages, namely:

- Stage 1 – Functionality
- Stage 2 – Price and Preferential Points

A bidder that scores less than **70 points out of 100** in respect of “**functionality**” will be regarded as submitting a non-responsive tender and will be disqualified and will not be evaluated further, i.e. for price and preferential points. The 80/20 Preference Point System will be applied to this tender for Stage 2 of the evaluation process.

Only tenderers who are registered on the Central Supplier Database (CSD) as accredited service providers are eligible to submit tenders. Registration is permitted prior to submission of tenders.

The physical address for collection of tender documents is **SRVM Cashier Office, 23 Middle Street, Kirkwood**.

Documents may be collected during working hours after **08:00 AM** on Thursday, **16 November 2022**.

A non-refundable tender deposit of **R500.00**, five hundred rand payable (by cash) to the Sundays River Valley Municipality is required on collection of the tender documents. Tenders may only be collected between **08:00AM** and **16:00 PM** during weekdays.

A compulsory clarification meeting with representatives of the Employer and the Engineer will take place at the on Bersheba Community Hall, in Bersheba Location, Latitude: 33°24'40.95"S Longitude: 25°32'49.17"E on **Thursday, 24 November 2022** starting at **10:00AM** where all the contractual and tendering aspects of the documents will be explained followed by a site inspection and an explanation of the technical requirements of the Contract.

Note that Tenderers who are more than **15 minutes** late for the meeting will not be allowed to attend the meeting and will not be allowed to sign the attendance register.

- 1.....Valid Tax Clearance Certificate OR Status Pin
- 2.....B-BBEE Certificate original or certified copy
- 3.....Certified ID Copies of All Company Directors if there's more than one Director.
- 4.....Completed MBD forms – 1, 4, 6.1, 6.2, 8 & 9
- 5.....Company registration Documents
- 6.....Municipal statement of Rates, Billing Clearance not older **than three months** or a Lease Agreement.
- 7.....Suppliers must be registered on the National Treasury Central Supplier Database.
- 8.....Proof of CIDB Grading must be supplied.

The closing time for receipt of tenders is **12:00 PM on Friday, 09 December 2022**. Tenders must be enclosed in sealed envelopes, bearing **"REFURBISHMENT OF ENON & BERSHEBA WATERBORNE SANITATION -SRVM 001/2023"** as well as the closing time and due date.

Tenders must be submitted in the **MUNICIPAL TENDER BOX** situated at **SRVM OFFICES, 23 Middle Street, Kirkwood** Tenders will be opened in public strictly at **12:00 PM** at the address stated above.

Tenders will be opened simultaneously at the address stated above. A tender must remain **valid for a period of 120 days from the closing date for the submission of tenders**. The lowest or any tender will not necessarily be accepted, and the Municipality reserves the right to accept a tender as a whole or in part. Telegraphic, telephonic, telex, facsimile, e-mail, posted and late tenders will not be accepted. Tenders may only be submitted on the tender documentation that is issued. More requirements for sealing, addressing, delivery, opening and assessment of tenders are stated in the Tender Data.
