**1. BACKGROUND**

The Agricultural Research Council (ARC) is a Research, Science and Technology institution of excellence in South Africa. As part of ongoing efforts to ensure workplace safety and compliance with Occupational Health and Safety requirements, the ARC requires repairs and upgrades to existing laboratory and emergency doors at the ARC Animal Production Campus in Irene.

**2. PURPOSE**

The purpose of this RFQ is to solicit quotations from suitably qualified service providers for the removal, refurbishment and installation of laboratory and emergency doors with existing handles and locks at the ARC Animal Production Campus: Irene.

**3. SCOPE OF WORK**

Refit door with new wood panel, re-stain and clad with external steel plate (5 doors).

Refit door with new wood panel and re-stain (35 doors).

Removal of existing doors (40 doors) and Re-installation of refurbished wooden doors (40 doors).

A compulsory briefing session will be conducted at ARC Irene Campus. Door schedules and locations will be provided at the briefing.

- 1.1 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.2 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

### 3. POINTS AWARDED FOR SPECIFIC GOALS

- 3.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 3.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of-
