1. SCOPE

1.1 Purpose

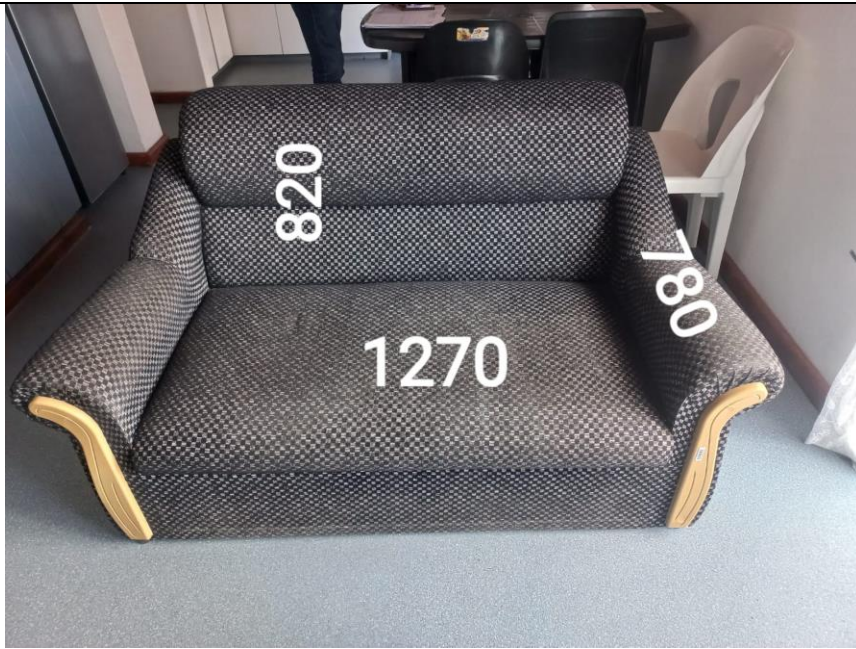
