1. INTRODUCTION AND PURPOSE

Disposal of all Marked Uniform of the Tshwane Metro Police Department for a period 12(Twelve) months on an as and when required basis.

2. BACKGROUND / DESCRIPTION

The Tshwane Metro Police identified the need for service providers to dispose of all Marked and Unmarked Uniforms to eliminate the possibility that these uniforms can be utilized by criminal. High crime rates relating to the impersonation of law enforcement officers and the subsequent misuse of official uniform and personal protective equipment during crime sprees necessitated the Tshwane Metro Police to take drastic measures to ensure that any uniform pieces and/or personal protective equipment that are withdrawn from operational duty, are managed controlled and disposed of in an accountable and auditable manner.

Disposal MAY ONLY be done within boundaries of the Gauteng, in the presence of; The Chief of Police: Tshwane Metro Police or his/her delegated representative, who will verify and certify all disposal certificates.

Collection, transport and delivery to disposal point, will be for the cost of the successful service provider.

Collection to be done at the TMPD Building (2010 Building / Mercedes on corner Schoeman Street, GPS: **will be confirmed with the successful services provider**

Collected uniform pieces **MUST** be weighed at the collection point in the presence of designated TMPD; and again, at the disposal point in the presence of designated TMPD personnel.

The designated TMPD personnel will at the disposal site, record photographic and video graphic evidence of the disposal of the items.

3. PROJECT SCOPE

Tshwane Metro Police Department (TMPD) uniform that include ranks and insignia, either marked or unmarked, that are required to be disposed of, may ONLY be disposed through any of the following processes:

- Controlled Burning.
- Controlled Dissolving.
- Motorized Shredding.

All Tshwane Metro Police Department (TMPD) uniform pieces (including ranks and insignia), either marked or unmarked will remain the property of the City of Tshwane until such time as a satisfactory disposal certificate have been issued by the appointed service provider.

All Tshwane Metro Police Department (TMPD) uniform pieces (including ranks and insignia), either marked or unmarked, submitted to the appointed bidder for disposal MUST be disposed of.

No Tshwane Metro Police Department (TMPD) uniform pieces (including ranks and insignia), either marked or unmarked, may not, not be disposed of – Non-compliance with this clause constitute a criminal offence.

No Tshwane Metro Police Department (TMPD) uniform pieces (including ranks and insignia), either marked or unmarked, may be sold or left the custody of the appointed service provider until such time as a satisfactory disposal certificate has been issued –

Non-compliance with this clause constitute a criminal offence.

All MARKED Tshwane Metro Police Department (TMPD) uniform pieces are embossed (i.e., decorated with a design that stands out in relief) with the initials, surname name and relevant insignia of the Tshwane Metro Police Department (TMPD) member to whom such uniform piece was issued. The City of Tshwane's regards the protection of its employee's personal information foremost and must ensure that this information is managed within the constraints of the Protection of Personal Information (POPI) Act, Act 4 of 2013. For this reason, no Tshwane Metro Police Department (TMPD) uniform pieces (including ranks and insignia), either marked or unmarked, leave the custody of the appointed service provider until such time as a satisfactory disposal certificate has been issued - Non-compliance with this clause constitute a criminal offence.

The proposed disposal process may ONLY be affected within the boundaries of the Gauteng Province and in the presence of the Chief of Police or, his/her duly delegated representative.

The Chief of Police or, his/her duly delegated representative, will institute the necessary auditable and accountability measures to enable reconciliation of Tshwane Metro Police Department (TMPD) uniform pieces (including ranks and insignia), either marked or unmarked, submitted for disposal versus the processed remains to ensure that all planned disposals were affected.

The City of Tshwane reserves the right to photograph and record any other audio-visual material perceived to be prudent during the disposal process as supporting evidence that the disposal process was correctly undertaken and successfully completed.

ONLY the Chief of Police or, his/her duly delegated representative, will be authorised to verify and certify that disposal certificates issued by the appointed bidders are correct and in accordance with the service claimed to have been rendered.

3.1.1 DISPOSAL PROCESS

Depending on the proposed disposal process of the appointed service provider which may include any of the following processes ONLY:

- Controlled Burning.
- Controlled Dissolving.
- Motorized Shredding.

The complete disposal process must be attended throughout by the Chief of Police or, his/her duly delegated representative for accountability purposes and the recording of photographic and video evidence for auditable purposes.

3.1.2 DISPOSAL CERTIFICATE

Upon completion of the disposal process, a Safe Disposal Certificate must be issued and signed by the Service Provider and subsequently verified and signed-off by the Chief of Police or his/her duly delegated representative. The Safe Disposal Certificate must include a unique reference number for record and audit purposes.

The required Safe Disposal Certificate must reflect and include the following:

- Indicate the number of Tshwane Metro Police Department (TMPD) uniform pieces collected.
- Indicating the description of types of Tshwane Metro Police Department (TMPD) uniform pieces planned for disposal.
- Indicating the type of disposal process to be utilised.
- Indicate the date and time of disposal.
- Indicate weight of Tshwane Metro Police Department (TMPD) uniform pieces per category (i.e., the weight of all caps, shirts, trousers, shoes, boots etc).

Quantity (units) of Tshwane Metro Police Department (TMPD) uniform pieces per category disposed.

4. Each person whose signature appears on the accompanying bid has been authorized by the bidder to determine the terms of, and to sign, the bid, on behalf of the bidder;
5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
